## LA VISTA CITY COUNCIL ORGANIZATIONAL MEETING December 5, 2006

A meeting of the City Council of the City of La Vista, Nebraska was convened in open and public session at 7:26 p.m. on December 5, 2006. Present were Mayor Kindig and Councilmembers: Sell, Ronan, Quick, Sheehan, Carlisle, McLaughlin, Ellerbeck, and Gowan. Absent: None. Also in attendance were City Attorney McKeon, Assistant City Administrator Ramirez, City Engineer Kottmann, City Clerk Buethe, Community Development Director Birch, Fire Chief Schuster, Library Director Schinker, Finance Director Lindberg, Police Chief Lausten, Building and Grounds Director Archibald, Recreation Director Stopak, City Planner Potter, Public Works Director Soucie, and Deputy City Clerk Lupomech.

A notice of the meeting was given in advance thereof by publication in the Times on November 23, 2006. Notice was simultaneously given to the Mayor and all members of the City Council and a copy of the acknowledgment of the receipt of notice attached to the minutes. Availability of the agenda was communicated to the Mayor and City Council in the advance notice of the meeting. All proceedings shown were taken while the convened meeting was open to the attendance of the public. Further, all subjects included in said proceedings were contained in the agenda for said meeting which is kept continuously current and available for public inspection within 10 days after said meeting and prior to the next convened meeting of said body.

Mayor Kindig called the meeting to order.

### I. CITY CLERK'S REPORT OF ELECTION RESULTS

Deputy City Clerk Lupomech read the results from the November 7, 2006, election as certified by the Sarpy County Election Commissioner. For the office of City Council Ward I Brenda L. Carlisle received 511 votes. For the office of City Council Ward II Terrilyn Quick received 621 votes and Klaus Lindner received 35 votes. For the office of City Council Ward III Alan W. Ronan received 438 votes. For the office of City Council Ward IV Kelly R. Sell received 844 votes.

Mayor Kindig administered the oath of office to Brenda L. Carlisle, re-elected to Ward I; Terrilyn Quick, re-elected to Ward II; Alan W. Ronan, re-elected to Ward III; and Kelly R. Sell, re-elected to Ward IV.

### III. ELECTION OF COUNCIL PRESIDENT

Councilmember Quick nominated Councilmember Carlisle for City Council President. Councilmember Sheehan seconded the nomination. Councilmember McLaughlin nominated Councilmember Gowan for City Council Present. Councilmember Sheehan seconded the nomination. A written ballot was cast and the results were 3 votes for Councilmember Gowan and 5 votes for Councilmember Carlisle. Councilmember Carlisle was elected City Council President.

Councilmember Sell thanked his family, friends, and the voters who had supported him in his re-election.
