## LA VISTA CITY COUNCIL ORGANIZATIONAL MEETING December 2, 2014

A meeting of the City Council of the City of La Vista, Nebraska was convened in open and public session at 7:00 p.m. on December 2, 2014. Present were Councilmembers: Frederick, Ronan, Sheehan, Thomas, Crawford, Quick, Hale and Sell. Also in attendance were City Attorney McKeon, Assistant City Administrator Ramirez, City Clerk Bueth, Police Chief Lausten, Director of Public Works Soucie, Director of Administrative Services Pokorny, City Planner Solberg, Recreation Director Stopak, Library Director Barcal, Human Resource Manager Garrod and City Engineer Kottmann.

A notice of the meeting was given in advance thereof by publication in the Times on November 19, 2014. Notice was simultaneously given to the Mayor and all members of the City Council and a copy of the acknowledgment of the receipt of notice attached to the minutes. Availability of the agenda was communicated to the Mayor and City Council in the advance notice of the meeting. All proceedings shown were taken while the convened meeting was open to the attendance of the public. Further, all subjects included in said proceedings were contained in the agenda for said meeting which is kept continuously current and available for public inspection at City Hall during normal business hours.

Mayor Kindig called the meeting to order and led the audience in the pledge of allegiance.

### II. CITY CLERK'S REPORT OF ELECTION RESULTS

City Clerk Bueth read the results of the General Election held on Tuesday, November 4, 2014 as certified by the Sarpy County Election Commissioner for the City of La Vista are as follows:

For the office of City Council Ward I Kim J. Thomas received 629 votes. For the office of City Council Ward II Terrilyn Quick received 1,165 votes and Troy White received 358 votes. For the office of City Council Ward III Alan W. Ronan received 659 votes. For the office of City Council Ward IV Kelly R. Sell received 615 votes and Mark White received 362 votes.

Councilmembers voting aye: Frederick, Ronan, Sheehan, Thomas, Crawford, Quick, Hale and Sell. Nays: None. Abstain: None. Absent: None. Motion carried. Councilmember Thomas is the Council President. Mayor Kindig thanked Councilmember Crawford for his service as Council President for the last two years.


