The City of La Vista Planning Commission held a meeting on Thursday, April 4, 2024, in the Harold "Andy" Anderson Council Chambers at La Vista City Hall, 8116 Park View Boulevard. A. Planned Unit Development – 14607 Chandler Road - AD Industrial Park – Fenton Construction

- i. **Staff Report – Staff Report – Cale Brodersen, Associate City Planner:** Brodersen stated that both applications on the agenda tonight are related to the same development proposal from Fenton Construction Inc. for the development of the AD Industrial Park. They are requesting approval of a Planned Unit Development and a Replat to create 6 separate lots for the construction of 6 industrial buildings. Brodersen reminded the Planning Commission members that these applications are related to the recent ETJ extension that the City performed, part of which included extending the City's zoning designations over the properties which reduced the intensity of permitted industrial development that was previously allowed for the property. Brodersen introduced Randy Kuszak, an engineer working on the project, and Victor Pelster representing the applicant.

Chair Alexander opened the Public Hearing.

B. Replat – 14607 Chandler Road - AD Industrial Park – Fenton Construction

- i. **Staff Report — Cale Brodersen, Associate City Planner:** Brodersen stated staff recommends approval of the replat of Tax Lot 19, to be replatted as AD Industrial Park Lots 1-6, contingent upon approval of the Planned Unit Development and Subdivision Agreement, as the replat is consistent with La Vista's Subdivision Regulations.

Sargus asked how many feet were between the neighbors to the south of the development and the proposed buildings. Kuszak identified on the map that the creek separated the properties. Brodersen mentioned that it would be close to 500 feet. Frey asked if all the trees would stay near the creek on the development side. Kuszak confirmed that the trees would remain and help provide a natural sound and visual screening barrier.
