LA VISTA CITY COUNCIL MEETING MAY 2, 2006

A meeting of the City Council of the City of La Vista, Nebraska was convened in open and public session at 7:00 p.m. on May 2, 2006. Present were Mayor Kindig and Councilmembers: Sell, Ronan, Quick, Sheehan, Carlisle, McLaughlin, Ellerbeck, and Gowan. Absent: None. Also in attendance were City Attorney McKeon, City Administrator Gunn, Finance Director Lindberg, Library Director Schinker, Recreation Director Stopak, Fire Chief Schuster, Police Chief Lausten, Community Development Director Birch, City Engineer Kottmann, Public Buildings and Grounds Director Archibald, Public Works Director Soucie, and City Clerk Ramirez.

REPORTS FROM CITY ADMINISTRATOR AND DEPARTMENT HEADS

Police Chief Lausten displayed the Seat Belt Compliance award that was presented to the City this past week. Lausten and three members of the City's Safety Committee traveled to Lincoln to receive the award. The award signifies that at least 80% of City employees were wearing their seat belts when arriving at work during two random checks.

Lausten reported that two La Vista police officers were now certified to operate the police motorcycle, which was recently acquired. The officers completed an intensive training course to receive the certification.

New Police Department equipment, including the police motorcycle and the Dodge Charger cruiser, will be on display in the parking lot at City Hall prior to the City Council meeting on May 16, 2006.

Public Works Director Soucie updated Council on various road construction projects. The southbound lane of 96th Street between Giles Road and Cornhusker Road remains closed. It is anticipated that La Vista's section will be open to local traffic by mid-June. The intersection of 96th Street and Cornhusker Road will then be closed for approximately seventy-five days to complete work in that area. The road work at 72nd & Giles being completed in conjunction with the Market Pointe development is continuing and completion is expected in early June.

Soucie reported on repair work at the City Swimming Pool. The fencing concerns that were pointed out in the study done by Water's Edge have been addressed. The diving board has been removed and the new slide has been delivered. Soucie indicated the pool will be ready for opening later in May.

Soucie informed Council that the Snow Plow Roadeo Finals are being held this week and several La Vista Public Works employees will be participating in the event.

Community Development Director Birch reported on her recent attendance at the National APA Conference in San Antonio. Birch stated that valuable information had been received regarding shopping center design, watershed design, etc. She thanked Council for the opportunity to attend the conference.

Recreation Director Stopak informed Council that the annual Arbor Day celebration was held on Monday, May 1, 2006 at City Park. Mayor Kindig and a second grade class from La Vista West were in attendance for the planting of a new tree. Stopak thanked the Public Works Department for their assistance in making the celebration a success.

Stopak reported on the golf leagues at La Vista Falls. He indicated that overall league numbers are up by 35 players which will result in an additional 500+ rounds of golf at the course this year. There will also be several new tournaments the course this year.

Stopak stated the Recreation Department will be hosting an "Ice Cream Social" at the Community Center on the last day of school, May 25, 2006. All area youth are welcome to attend to kick off the summer season.

B. DISCUSSION/PRESENTATION – PAPILLION CREEK WATERSHED PARTNERSHIP

Paul Woodward, an engineer with the Papio – Missouri River NRD, presented a report on the Papillion Creek Watershed Partnership. The City of La Vista has been a member of the Partnership since 2001 and the NRD is the administrator of the Partnership. Woodward stated the focus of the Partnership is water quality, flood control, and green area preservation.

Woodward's presentation included a review of the Partnership mission, watershed facts regarding our area, and permit requirements. He indicated that a request will be coming to the City Council in August of this year to adopt an ordinance that would give cities enforcement authority over water quality issues, require grading permits for new development, and approve the design manual. The timeline for adoption, policies, and fee recommendations were also discussed.

C. RESOLUTION – FIRST AMENDMENT TO SUBDIVISION AGREEMENT – SOUTHPORT EAST REPLAT ONE

Councilmember Quick introduced and moved for the adoption of Resolution No. 06-066: A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF LA VISTA, NEBRASKA APPROVING THE FIRST AMENDMENT TO THE SUBDIVISION AGREEMENT FOR SOUTHPORT EAST REPLAT ONE IN A FORM SATISFACTORY TO THE CITY ADMINISTRATOR AND CITY ATTORNEY.

WHEREAS, the City did on August 21, 2002, approve the plat for Lots 1-3, Southport East Replat One; and

WHEREAS, the City has proposed an amendment for tracking purposes only.

NOW THEREFORE, BE IT RESOLVED, that the First Amendment to the Subdivision Agreement presented at the May 2, 2006, City Council meeting for Southport East Replat One be, and hereby is approved, and the Mayor and City Clerk be and hereby are, authorized to execute same on behalf of the City with such revisions or amendments thereto that the City Administrator and City Attorney may determine necessary to carry out the intent of the City Council.

D. RESOLUTION – INTERLOCAL COOPERATION AGREEMENT – LEAGUE ASSOCIATION OF RISK MANAGEMENT (LARM)

Councilmember Sell introduced and moved for the adoption of Resolution No. 06-067: A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF LA VISTA, NEBRASKA RELATING TO THE TERM OF PARTICIPATION IN THE LEAGUE ASSOCIATION OF RISK MANAGEMENT.

WHEREAS the City of La Vista is a member of the League Association of Risk Management (LARM); and

WHEREAS, section 8.10 of the Interlocal Agreement for the Establishment and Operation of the League Association of Risk Management provides that a member may voluntarily terminate its participation in LARM by written notice of termination given to LARM and the Director of Insurance at least 90 days prior to the desired termination date and that members may agree to extend the required termination notice beyond 90 days in order to realize reduced excess coverage costs, stability of contribution rates, and efficiency in operation of LARM; and

WHEREAS, the Board of Directors of LARM has adopted a plan to provide contribution credits in consideration of certain agreements by members of LARM as provided in the attached letter; and

WHEREAS, the Mayor and City Council have determined that it is in the best financial interest of the City to extend the term of agreement by three years and establish notice of termination terms in order to receive participation discounts.

NOW THEREFORE, BE IT RESOLVED that the Mayor and City Council of the City of La Vista, Nebraska, in consideration of the contribution credits provided under the LARM Board's plan, agrees to provide written notice of termination at least 180 days prior to the desired termination date, which date shall be no sooner than September 30, 2009, and hereby authorize the Mayor to execute the necessary agreements to implement the action authorized herein.

TO PROVIDE FOR PARTICIPANT LOANS UNDER THE CITY OF LA VISTA DEFERRED COMPENSATION PLAN AND TRUST.

WHEREAS, the City of La Vista maintains a retirement plan and trust for the City Administrator and Assistant City Administrator that is intended to satisfy the requirements of Internal Revenue Code Section 457 and is named the City of La Vista Deferred Compensation Plan and Trust, as amended and restated effective January 1, 2002 ("Plan"); and

WHEREAS, Article XII of the Plan authorizes the City of La Vista to amend the Plan; and

WHEREAS, Article VIII allows the City to elect to allow participant loans from the Plan. Pursuant to VII of the Plan, as modified by Exhibit "A" attached to and incorporated into the Plan by reference, the City has a current election not to make loans from the Plan available to Participants; and

WHEREAS, the City desires to change said election and allow Participants to obtain loans from the Plan.

NOW, THEREFORE, BE IT RESOLVED, that the City elects to allow Participants to obtain loans from the Plan.

FURTHER RESOLVED, that Amendment No. 2 to the Plan to allow Participant loans is presented at this meeting, and said Amendment No. 2 is hereby adopted and approved.

FURTHER RESOLVED, that a Loan Policy establishing written guidelines for Participant loans from the Plan is presented at this meeting, and said Loan Policy is hereby adopted and approved.

FURTHER RESOLVED, the Mayor and City Clerk are hereby authorized to execute said Amendment No. 2 and Loan Policy and to take such further actions as are necessary or appropriate to carry out the resolution approved herein. The City Clerk shall send copies of this resolution, Amendment No. 2 and Loan Policy to the Plan Administrator.

Councilmember Carlisle introduced and moved for the adoption of Resolution No. 06-069: A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF LA VISTA, NEBRASKA AMENDING THE SECTION 125 PRE-TAX SALARY REDUCTION PLAN (FSA) AND THE ADMINISTRATIVE SERVICES AGREEMENT WITH PRINCIPAL FINANCIAL GROUP REGARDING SAID PLAN.

WHEREAS, the City of La Vista has a Section 125 Pre-Tax Salary Reduction Plan (FSA) in place for employees; and

WHEREAS, Principal Life Insurance Company ("Principal") and City of La Vista have entered into an Administrative Services Agreement whereby Principal has agreed to perform certain services for City of La Vista on behalf of its employee benefit plan ("Plan"); and

WHEREAS, the Administrative Services Agreement sets for the rights and obligations of the parties pursuant to the Health Insurance Portability and Accountability Act of 1996, ("HIPAA") and its implementing regulations (collectively, the "Privacy Rule"); and

WHEREAS, HIPAA and its implementing regulations (collectively the "Security Rule") require the Plan to implement administrative, physical, and technical safeguards to protect the confidentiality, integrity and availability of electronic protected health information that it creates, maintains, receives or transmits; and

WHEREAS, under the Security Rule, Principal is considered a Business Associate of the Plan by reason of the duties it has undertaken pursuant to the Original Agreement; and

WHEREAS, the Security Rule requires Business Associate and the Plan to enter into a Business Associate Agreement in order to permit Business Associate to create, maintain, receive and transmit electronic protected health information on behalf of the Plan.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and City Council, in order to comply with the requirements of the Security Rule, Business Associate, City of La Vista, and the Plan, hereby amend the Plan and the Administrative Services Agreement with Principal Life Insurance Company as outlined in the Amendments presented at this meeting.

BE IT FURTHER RESOLVED, that the Mayor and City Clerk are hereby authorized to execute said Amendments and to take such further actions as are necessary or appropriate to carry out the resolution approved herein.

WHEREAS, the City Clerk presents at this meeting an individual bond previously filed with her.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and City Council make and approve the following findings: The Bond is in joint and several form, payable to the City of La Vista in the penalty amount of \$5,000, conditioned for the faithful discharge of the duties of the office of the person giving said Bond; the corporate sureties of said Bond are legally authorized to transact business in the State of Nebraska; the Bond has been executed by the principal and sureties thereof and the required oath has been endorsed thereon and executed by the principal; the Bond has been previously filed with the City Clerk; and all applicable legal requirements with respect to said Bond have been satisfied.

Councilmember Sheehan informed Council that he would be attending a prayer service for elected officials on the Mayor's behalf on May 5.


