SYNOPSIS

A resolution has been prepared authorizing the purchase of one (1) 2017 Chevrolet 3500, Crew Cab, 4x4, Heavy Duty pickup truck from Sid Dillon Commercial /Fleet Division, 257 West "A" Street, Wahoo, NE 68066 for an amount not to exceed \$57,300.00.

The FY17 General Fund Budget provides funding for the proposed purchase.

BACKGROUND

The proposed purchase is to replace #1108 a 1980 Chevrolet Pickup Truck which is not equipped with a plow. In addition, the cost of repairs to keep the old truck in service exceeds the value of the new truck. A new, plow-equipped truck will allow for more efficient snow removal operations. The new truck will be used by the Streets Division for daily operations and used by all divisions for snow removal operations.

The truck is being purchased off the University of Nebraska Lincoln Contract #2615-16-2510.
