## LA VISTA CITY COUNCIL MEETING NOVEMBER 6, 2018

A meeting of the City Council of the City of La Vista, Nebraska was convened in open and public session at 6:00 p.m. on November 6, 2018. Present were Councilmembers: Frederick, Ronan, Sheehan, Thomas, Crawford, and Sell. Also in attendance were City Attorney McKeon, City Administrator Gunn, Assistant City Administrator Ramirez, City Clerk Buethe, Police Chief Lausten, City Engineer Kottmann, Assistant Library Director Norton, Director of Administrative Services Pokorny, Finance Director Miserez, Recreation Director Stopak, Community Development Director Birch, and Human Resources Director Czarnick.

A notice of the meeting was given in advance thereof by publication in the Times on October 24, 2018. Notice was simultaneously given to the Mayor and all members of the City Council and a copy of the acknowledgment of the receipt of notice attached to the minutes. ## REPORTS FROM CITY ADMINISTRATOR AND DEPARTMENT HEADS

Director of Administrative Services Pokorny reported that he has received a scholarship to attend the GFOA Conference.

Recreation Director Stopak reported that Metro's Soctoberfest hosted 124 teams and 218 games. 147 games were held at the City's soccer complex for \$4,920 in field rental. He also reported that the Halloween Safe Night attendance was 1,125 and that the Tree Lighting will be on Monday, November 26.

Chief Lausten reported that the Captain Waugh is leaving the La Vista Police force December 21 to take the position of Police Chief in Kearney. He also reported that the first Sarpy/Douglas County Law Enforcement Academy graduation will be held on December 21 at the Embassy Suites. He announced that Jeff Sinnett will be inducted into the Omaha Softball Hall of Fame for participating in softball for 35 years.
