**SYNOPSIS**

A resolution has been prepared to authorize the purchase of one (1) 2019 Ford F-550 Medium Duty Truck, from Andersen Ford, Lincoln, NE in an amount not to exceed \$78,327.00.

**FISCAL IMPACT**

The FY 19/20 Biennial Budget provides funding for the proposed purchase.

**BACKGROUND**

Last year the Public Works Department did a trial period running medium duty pick-up trucks for snow removal instead of the larger dump trucks. It was determined that this is a viable option to provide efficient and effective snow removal in some of the City’s smaller districts. The Public Works Capital Purchasing Team determined that the most effective use for this vehicle would be to make it dual purpose, serving as a snow removal vehicle in the winter and a concrete repair truck in the summer. This truck will be outfitted with a utility box, snow plow, and slide-in sander to fulfill this role. This particular truck will replace truck #1128, a 1997 International single axle dump truck.

The truck is being purchased off the State of Nebraska Contract #14704 OC.
