A resolution has been prepared to approve the purchase of an upgrade to the Barracuda Web Filter from MNJ Technologies Direct, Inc. in an amount not to exceed \$9,440.

BACKGROUND

For website security, the City currently utilizes Barracuda Web Filter. An upgrade to the system is necessary in order to continue to provide content filtering, full web protection, blocking ransomware, malware and malicious domains for users on and off the network.
