SYNOPSIS

A resolution has been prepared authorizing the purchase of (1) one 2020 Scorpion TL3 Truck Towed Attenuator with Arrowboard from Traffix Devices, San Clemente, California in an amount not to exceed \$21,720.20.

The FY 19/20 Biennial Budget provides funding for the proposed purchase.

BACKGROUND

In an effort to ensure the safety of our Public Works staff, the capital equipment team is recommending the purchase of a truck towed attenuator to protect staff performing street maintenance related work.

The proposed vehicle will be purchased through the state of Nebraska, contract #15241 OC.

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF LA VISTA, NEBRASKA, AUTHORIZING THE PURCHASE OF ONE (1) 2020 SCORPION TL3 TRUCK TOWED ATTENUATOR WITH ARROWBOARD FROM TRAFFIX DEVICES, SAN CLEMENTE, CALIFORNIA IN AN AMOUNT NOT TO EXCEED \$21,720.20.

WHEREAS, the City Council of the City of La Vista has determined that the purchase of a Scorpion TL3 truck towed attenuator with arrowboard is necessary; and

WHEREAS, the FY 19/20 Biennial Budget provides funding for this purchase; and

WHEREAS, Subsection (C) (9) of Section 31.23 of the La Vista Municipal code requires that the City Administrator secure council approval prior to authorizing any purchases over \$5,000;
