A meeting of the City Council of the City of La Vista, Nebraska was convened in open and public session at 6:00 p.m. on February 2, 2021. WHEREAS, the Mayor and City Council of the City of La Vista find it necessary to do grade control improvements near the northeast corner of Lot 14, City Centre; and

WHEREAS, these grade control improvements are necessary to build a dual purpose fire land and pedestrian walkway to access future buildings and amenities; and

WHEREAS, this agreement would allow all grade control improvements to be done as one project with City Centre I, LLC as the lead; and

WHEREAS, anticipated total costs of the project are \$264,012.10 of which the City of La Vista share is anticipated to be \$112,233.28. The cost breakdown is included in the agreement.

NOW, THEREFORE BE IT RESOLVED, that the Mayor and City Council of the City of La Vista hereby authorize the execution of an Improvement and Easement Agreement with La Vista City Centre, LLC and City Centre I, LLC to construct grade control improvements near the northeast corner of Lot 14, City Centre in a form satisfactory to the City Administrator or designee.

WHEREAS, the recreation area formally has not been named, but has been referred to as Civic Center Park; and

WHEREAS, the future plans include the installation of a connection under 84th Street between this new recreation area and the land that is the current location of the municipal swimming pool and some smaller baseball fields; and

WHEREAS, the Park and Recreation Advisory Committee held a public hearing at their meeting on January 20, 2021 to discuss naming these areas as required by the Council Policy Statement, and they are recommending the name Central Park; and

WHEREAS, the official park name will be Central Park;

NOW, THEREFORE BE IT RESOLVED, that the Mayor and City Council of La Vista, Nebraska does hereby officially name the area currently referred to as Civic Center Park and the area immediately west of 84th Street as Central Park.

PLANNING COMMISSION MINUTES
JANUARY 21, 2021 6:30 P.M.

The City of La Vista Planning Commission held a meeting on Thursday, January 21, 2021 in the Harold "Andy" Anderson Council Chamber at La Vista City Hall, 8116 Park View Boulevard. Vice-Chairman Harold Sargus called the meeting to order at 6:30 p.m. with the following members present: Mike Krzywicki, Gayle Malmquist, Harold Sargus, Patrick Coghlan, John Gahan, Kathleen Alexander, and Josh Frey. Members absent were Jason Dale, Mike Circo, and Kevin Wetuski. Also, in attendance were Chris Solberg, Deputy Community Development Director; Bruce Fountain, Community Development Director; Cale Brodersen, Assistant City Planner; Pat Dowse, City Engineer; and Meghan Engberg, Permit Technician.

Legal notice of the public meeting and hearing were posted, distributed and published according to Nebraska law. Notice was simultaneously given to all members of the Planning Commission. All proceedings shown were taken while the convened meeting was open to the attendance of the public.

1. Call to Order

The meeting was called to order by Co-Chairman Sargus 6:30 p.m. Copies of the agenda and staff reports were made available to the public.

2. Approval of Meeting Minutes – January 7, 2021

Malmquist moved, seconded by Krzywicki to approve the January 7th minutes. **Ayes: Krzywicki, Gahan, Alexander, Coghlan, Frey, and Malmquist. Nays: None. Abstain: Sargus. Absent: Wetuski, Circo, and Dale. Motion Carried, (6-0-1)**

3. Old Business

None.

4. New Business

A. Conditional Use Permit – 12005 Portal Road – 4Seams Academy, LLC

- i. **Staff Report – Cale Brodersen:** Brodersen stated that the applicant, 4Seams, LLC, has requested a Conditional Use Permit to operate an indoor recreation facility at 12005 Portal Rd. He said that they are looking to operate a baseball and softball training facility in a new industrial flex space on Lot 5 Papio Valley 2 Business Park. Brodersen said that this building has 6 bays and the application will be occupying bays 1-5 and the owner of the building will be occupying bay 6.

Brodersen said that one reason the City of La Vista requires a Conditional Use Permit for facilities such as these is to ensure that the site can adequately handle the

parking and traffic something like this can generate. Brodersen said that based off the expected maximum occupancy for peak times, the requirement for off-street parking in La Vista's Zoning Ordinance is 28 stalls, and this facility has 61 dedicated stalls in the front of the building. He mentioned that one of the conditions that they placed in the permit was that if they do run over that amount of parking, there is a very large concrete area in the back of the building they may require to be striped if necessary. He then mentioned that if they also start to experience traffic backing out on to public streets, the City could require operational changes or physical improvements to make sure that stacking doesn't occur.

Staff recommends approval of the Conditional Use Permit for Lot 5 Papio Valley 2 Business Park, as the request is consistent with La Vista's Comprehensive Plan and Zoning Ordinance.

ii. **Public Hearing; Sargus opened the public hearing.**

Sean Schrader, one of the business owners of 4Seams Academy, LLC, spoke on behalf of the project. He gave some history on his involvement with baseball and feels that opening this facility would give kids an opportunity to have somewhere to practice. He said that they have been working on this for 2 years now to be able to give kids a place to take their dreams to the next level. Schrader said that as far as the building goes, he feels that they have addressed the questions and issues Cale had and are continuing to address the other issues that have come up.

Cheri Williamson, one of the business owners, spoke on behalf of the project. She mentioned her personal involvement and history with baseball. She said that one of the reasons that she wanted to get involved in this project is because there is such a need for this community to have a facility that they want to provide for these kids.

Dan Tinnell, one of the business owners, spoke on behalf of the project. He said they have been working on this project for 2 years with a lot of ups and downs. He said that they want to fight and go forward to get this facility open. Tinnell described the need for the facility for his players and other players. He then thanked the Commission for allowing them to speak.

Steve Thornburg, Papillion/La Vista Fire Marshall, spoke during the public hearing to voice his concerns. He mentioned that the applicant has the occupant load at 110, but that the calculated occupant load under the building code is over 2,000. He said that they deal with worst case scenario in the code and if they have the room, they'll bring the people. He said that parking is also an issue and that they are looking out for the safety of everybody who goes into the building. Thornburg said that he is still waiting for plans from their architect because he hasn't gotten all of his questions answered. He feels that there shouldn't have been any work done inside the building yet as he claimed it hasn't been permitted.

Sargus asked if 110 versus 2,000 was a good thing.

Thornburg said it's a good thing if they actually limit it to that number and it's being policed.

Coghlan asked if Thornburg as Fire Marshal, could put a restriction on occupancy because of those issues.

Thornburg said that he can't limit occupant load except for those based off exiting and other related issues.

Krzywicki said that the proposed Conditional Use Permit sets the maximum occupancy in it, so if they exceed it, the permit would be voided. He then said that if there are more people than would normally be there that create traffic and other issues that would come up as a violation of the permit.

Thornburg replied wanting to know who is going to police that in this location.

Coghlan asked in a facility like that, what would 2,000 people do.

Thornburg said they wouldn't be able to practice, but there are other things such as open houses, registrations, etc., that could cause an issue.

Coghlan said that he sees that happening a very small percentage of the time. He said that he grew up in those facilities too and to have 2,000 people in batting cages and throwing areas would be detrimental to their business.

Schrader came back up to podium and said that the occupancy load being set at 2,000 is pretty ridiculous and they wouldn't be able to function as a training facility with that many people in there. He said that he wasn't sure of the exact codes the Fire Marshal was referring to, but the ability to operate with that many, let alone the insurance costs and liability issues, would be impossible. He said there's no way you'd be able to be in there swinging baseball bats with that many people. He said that he understood there might be special days where there'd be an influx, but that it wouldn't be as bad as the traffic at The Volleyball Academy. Schrader mentioned that there are cages with set dimensions and netting within the facility, with hallway space for people to travel about. He said that normal traffic would be a team of 10-12 players and a few coaches.

Sargus said that he was excited to see in the operating statement that the applicant is in talks with a sports performance coach that may sublease.

Schrader said that would be in bay 5 and that there would be professional players who would use that bay.

Sargus asked about the impacts on parking and building occupancy of a professional player coming in for training.

Schrader said that he didn't think they're trying to draw crowds; they focus on private training sessions, not events like autograph signings. Tinnell said that those

players are training during the day while the kids are in school, so there wouldn't be a concern for crowds.

Brodersen came forward to give clarification on a couple things mentioned during this discussion. He said that the applicant will still be required to meet all the life safety codes. So even after the approval of the Conditional Use Permit, they won't be able to occupy the space until they've worked with Thornburg to meet all the life safety codes. He then mentioned that they do have the occupancy limit in the Conditional Use Permit, so if they do experience large influxes and are going over that 110 amount, they will be in violation of the CUP and will be required to make sure that they are not going above that level or lose their CUP. Brodersen said that Community Development staff conduct annual inspections on every approved Conditional Use Permit, Staff will monitor occupancy limits, parking and complaints on this facility and follow up as required

Solberg pointed out items D, E, and G of the Conditional Use Permit in relation to the items that were recently discussed. He said that the occupancy issue was something that had just come up in the last 24 hours and is something that needs to be dealt with prior to getting their Certificate of Occupancy. He then said the applicant's architect will have to work with both the Building Department and Papillion Fire to resolve the issue and that there is time between now and then to resolve the issue.

Sargus closed the Public Hearing.

Krzywicki asked for confirmation that if the Planning Commission and City Council approve the Conditional Use Permit, that the Conditional Use Permit lists the specific remaining requirements that must be met before they can operate.

Solberg said yes, they still need to get their C.O. to start operating.

Frey asked if both entrances are paved to the street that are noted in one of the packet attachments.

Brodersen said they are.

iii. **Recommendation:** Coghlan moved, seconded by Frey, to recommend approval of the Conditional Use Permit for Lot 5 Papio Valley Business Park, as the request is consistent with La Vista's Comprehensive Plan and Zoning Ordinance. **Ayes:** Krzywicki, Gahan, Alexander, Coghlan, Sargus, Frey, and Malmquist. **Nays:** None. - **Abstain:** None. **Absent:** Wetuski, Circo, and Dale. **Motion Carried, (7-0)**

A. COMPREHENSIVE PLAN: The Comprehensive Plan Future Land Use Map designates this property for industrial use. This proposal is consistent with the comprehensive plan.

C. TRAFFIC AND ACCESS:

1. The property currently has driveway access off both S. 121st Street and Portal Road.

D. UTILITIES:

1. The property has access to all necessary utilities.

E. PARKING REQUIREMENTS:

1. The applicant has indicated that the maximum number of building occupants during peak time shall be 110 persons. Per the La Vista Zoning Ordinance Section 7.06, the minimum number of provided off-street parking stalls for recreational facilities shall be one (1) space per 4 occupants. 4Seams Academy will have a minimum of 61 dedicated parking stalls which greatly exceeds the minimum of 28 stalls required by the La Vista Zoning Ordinance.

2. If overflow parking is needed, 4Seams Academy will also have access to the large un-striped lot just south of the facility on the same lot. If the provided off-street parking is not sufficient and the overflow lot is regularly utilized, the applicant will be required to stripe additional parking stalls on the southern parking lot.
3. No on-street parking will be allowed.

IV. REVIEW COMMENTS:

- A. A Certificate of Occupancy must be granted by the Chief Building Official and the Fire Marshal prior to occupation and use of the facility.
- B. As 4Seams Academy will primarily be using the facility during typical non-work hours (evenings and weekends), the impact of this use on surrounding businesses is expected to be minimal. The Conditional Use Permit limits occupancy in the facility to 110 people, further limiting any potential negative impacts on surrounding properties.
- C. Annual inspections are conducted by the Community Development Department on all active Conditional Use Permits to ensure compliance.

V. STAFF RECOMMENDATION – CONDITIONAL USE PERMIT:

Staff recommends approval of the Conditional Use Permit for Lot 5 Papio Valley 2 Business Park, as the request is consistent with La Vista's Comprehensive Plan and Zoning Ordinance.

VI. PLANNING COMMISSION RECOMMENDATION – CONDITIONAL USE PERMIT:

The Planning Commission held a public hearing on January 21, 2021 and voted unanimously to recommend approval of the Conditional Use Permit for Lot 5 Papio Valley 2 Business Park, as the request is consistent with La Vista's Comprehensive Plan and Zoning Ordinance.







Conditional Use Permit for Indoor Recreational Facility

This Conditional Use Permit issued this 16th day of February 2021, by the City of La Vista, a municipal corporation in the County of Sarpy County, Nebraska ("City") to 4Seams Academy, LLC ("Owner"), pursuant to the La Vista Zoning Ordinance.

WHEREAS, Owner wishes to locate and operate an indoor recreational facility upon the following described tract of land within the City of La Vista zoning jurisdiction:

Lot 5 Papio Valley 2 Business Park, located in the NE 1/4 Section 19, Township 14 North, Range 12 East of the 6th P.M. Sarpy County, Nebraska, located at 12005 Portal Road STE 1-5.

WHEREAS, Owner has applied for a conditional use permit for the purpose of locating and operating a indoor recreational facility; and

WHEREAS, the Mayor and City Council of the City of La Vista are agreeable to the issuance of a conditional use permit to the Owner for such purposes, subject to certain conditions and agreements as hereinafter provided.

NOW, THEREFORE, BE IT KNOWN THAT subject to the conditions hereof, this conditional use permit is issued to the Owner to use the area designated on Exhibit "B" hereto for an indoor recreational facility, said use hereinafter being referred to as "Permitted Use" or "Use".

Conditions of Permit

The conditions to which the granting of this permit is subject are:

1. Breach of any terms hereof shall cause permit to automatically expire and terminate without any further action required of the City.
2. In respect to the Permitted Use:
 - a. The use shall be limited to the type of operation as described in the Owner's Operational Statement (Exhibit "A") and in the City staff report presented with the Council agenda item to consider this permit. Any proposed change in the Permitted Use or operational characteristics including, but not limited to, the hours of operation or additional or different activities or intensity of activities on the property, shall require such reviews, amendments to the Conditional Use Permit, and approvals as the Planning Department in its sole discretion determines necessary or appropriate.
 - b. A site plan showing the property boundaries of the tract of land, proposed structures, parking, access points, and drives is attached to the permit as Exhibit "B".
 - c. Hours of operation for said indoor recreational facility will be Monday through Friday from 10:00 a.m. – 10:00 p.m., and Saturday and Sunday from 8:00 a.m. to 10:00 p.m.
 - d. The maximum number of occupants allowed in the facility will be 110.
 - e. Off-street parking shall be provided for the Permitted Use and the number of parking spaces shall be adequate to accommodate the patrons and guests of the Permitted Use without negatively impacting or limiting the number of parking spaces for other existing or future tenants or surrounding businesses, or negatively impacting traffic or traffic flows on, in or around the Property or streets. The provided

off-street parking shall be consistent with the site plan attached as "Exhibit B," which parking Owner has represented to City is in accordance with City requirements and sufficient for the Permitted Use. Additional off-street parking on the property will be required if deemed necessary by the Planning Department, and the Owner at its cost shall be solely responsible for obtaining use of or constructing any such additional off-street parking. The requirements, location and other specifications of any additional off-street parking shall be subject to Planning Department or City Engineer approval. The Planning Department or City Engineer may require that additional parking stalls be striped in the potential overflow parking area located on the south side of the property if the Permitted Use requires additional off-street parking. On-street parking on Portal Road, South 121st Street, South 120th Street, or otherwise in connection with the Permitted Use shall be prohibited. Stacking of vehicles in connection with the Permitted Use out onto any public street is prohibited. If vehicles stacking onto Portal Road or South 121st Street becomes a safety threat as determined by the City Engineer, the City may require additional physical or operational improvements to mitigate the risk of stacking. The inability of Owner to stop vehicles in connection with the Permitted Use from stacking into public streets is a valid cause for termination of this permit. A first response to the potential stacking of vehicles into the street, as provided by the applicant, is described in Exhibit "C" attached to this permit.

- f. There shall be no storage, placement or display of goods, supplies or any other material, substance, container or receptacle outside of the indoor recreational facility, except appropriately screened trash receptacles and those approved in writing by the City.
- g. There shall not be any games, tournaments, or other events that draw a larger spectator crowd than typical training or camp activities or that would result in the maximum number of occupants in subsection 2d above being exceeded.
- h. Owner shall obtain all required permits from the City of La Vista and shall comply with any additional requirements as determined by the Chief Building Official, including, but not limited to, building, fire, and ADA.
- i. Owner shall comply (and shall ensure that all employees, invitees, suppliers, structures, appurtenances and improvements, and all activities occurring or conducted, on the premises at any time comply) with any applicable federal, state and/or local laws, rules, or regulations, as amended or in effect from time to time, including, but not limited to, applicable environmental or safety laws, rules or regulations.
- j. Owner hereby indemnifies the City and all officials, officers, employees, and agents of the City ("Indemnified Parties") against, and holds the Indemnified Parties harmless from, any liability, loss, claim or expense whatsoever (including, but not limited to, reasonable attorney fees and court cost) arising out of or resulting from the acts, omissions or negligence of the Owner, or Owner's agents, employees, assigns, suppliers or invitees, including, but not limited to, any liability, loss, claim or expense arising out of or resulting from any violation on the premises of any environmental or safety law, rule or regulation.

3. The Owner's right to maintain the use as approved pursuant to these provisions shall be based on the following:

- a. An annual inspection to determine compliance with the conditions of approval; or more frequent inspection upon any complaint to the City. The conditional use permit may be revoked upon a finding by the City that there is a violation of the terms of approval or this permit.
- b. The use authorized by the conditional use permit must be initiated within one (1) year of approval and shall become void two (2) years after the date of approval unless the Owner has fully complied with the terms of approval.
- c. All obsolete or unused structures, accessory facilities or materials with an environmental or safety hazard shall be abated and/or removed at Owner's expense within twelve (12) months of cessation of the conditional use.

4. Notwithstanding any other provision herein to the contrary, this permit, and all rights granted hereby, shall expire and terminate as to a permitted use hereunder upon the first of the following to occur:

- a. Owner's abandonment of the permitted use. Non-use thereof for a period of twelve (12) months shall constitute a presumption of abandonment.

- b. Cancellation, revocation, denial or failure to maintain any federal, state or local permit required for the Use.
- c. Owner's breach of any other terms hereof.

5. In the event of the Owner's failure to promptly remove any safety or environmental hazard from the premises, or the expiration or termination of this permit and the Owner's failure to promptly remove any permitted materials or any remaining environmental or safety hazard, the City may, at its option (but without any obligation to the Owner or any third party to exercise said option) cause the same to be removed at Owner's cost (including, but not limited to, the cost of any excavation and earthwork that is necessary or advisable) and the Owner shall reimburse the City the costs incurred to remove the same. Owner hereby irrevocably grants the City, its agents and employees the right to enter the premises and to take whatever action as is necessary or appropriate to remove the structures or any environmental or safety hazards in accordance with the terms of this permit, and the right of the City to enter the premises as necessary or appropriate to carry out any other provision of this permit.

6. If any provision, or any portion thereof, contained in this agreement is held to be unconstitutional, invalid, or unenforceable, the remaining provisions hereof, or portions thereof, shall be deemed severable, shall not be affected, and shall remain in full force and effect.

Miscellaneous

The conditions and terms of this permit shall be binding upon Owner, his successors and assigns.

- 1. Delay of City to terminate this permit on account of breach of Owner of any of the terms hereof shall not constitute a waiver of City's right to terminate, unless it shall have expressly waived said breach and a waiver of the right to terminate upon any breach shall not constitute a waiver of the right to terminate upon a subsequent breach of the terms hereof, whether said breach be of the same or different nature.
- 2. Nothing herein shall be construed to be a waiver or suspension of, or an agreement on the part of the City to waive or suspend, any zoning law or regulation applicable to the premises except to the extent and for the duration specifically authorized by this permit.
- 3. Any notice to be given by City hereunder shall be in writing and shall be sufficiently given if sent by regular mail, postage prepaid, addressed to the Owner as follows:

An ordinance has been prepared to approve an amendment to Municipal Code Section 131.09 Loud, Unnecessary Noises allowing for exceptions for event center type facilities.

BACKGROUND

An ordinance has been prepared to consider the adoption of an amendment to Section 131.09 of the La Vista Municipal Code related to loud, unnecessary noises. The proposed amendment adds two items to the list of exemptions from the Ordinance. The first exempts noises emanating from an event center in accordance with a current approved Conditional Use Permit from the City of La Vista, subject to specific curfew times. The second exempts City, community, or other events conducted or authorized by the City.

A copy of the red-lined draft Ordinance showing the proposed changes is attached.

ORDINANCE NO. ____

AN ORDINANCE TO AMEND SECTIONS 131.09 OF THE LA VISTA MUNICIPAL CODE RELATING TO LOUD, UNNECESSARY NOISES, TO PROVIDE FOR SEVERABILITY AND TO PROVIDE FOR THE EFFECTIVE DATE.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF LA VISTA, NEBRASKA, AS FOLLOWS:

SECTION 1: Amendment of Section 131.09. Section 139.01 of the La Vista Municipal Code is hereby amended to read as follows:

§ 131.09 LOUD, UNNECESSARY NOISES.

(A) Findings. It is found and declared that:

- (1) The making, creation or maintenance of noises or sounds that are unreasonably loud, raucous, jarring, disturbing or a nuisance are a detriment to the public health, comfort, convenience, safety, welfare and prosperity of the residents of this city.
- (2) The necessity in the public interest for the provisions and prohibitions hereinafter contained and enacted is declared as a matter of legislative determination and public policy, and it is further declared that the provisions and prohibitions hereinafter contained and enacted are in pursuance of and for the purpose of securing and promoting the public health, comfort, convenience, safety, welfare and prosperity and the peace and quiet of this city. ('79 Code, § 6-338)

(B) Unlawful to make, continue. It shall be unlawful for any person to create, assist in creating, permit, cause, continue or permit the continuance of any sound or noise that is unreasonably loud, raucous, jarring, disturbing or a nuisance within the limits of the city. The term "disturbing" as used in this section shall mean actual or imminent interference with peace or good order. ('79 Code, § 6-339)

(C) Enumeration; exceptions.

(1) Enumerations. The following sounds or noises, among others, are declared to be unreasonably loud, raucous, jarring, disturbing or a nuisance in violation of this code, but such enumeration shall not be deemed to be exclusive, namely:

(a) Horns, signaling devices and the like. The sounding of any horn, whistle or other signaling device on any automobile, truck, motorcycle or other vehicle on any private, residential or commercial property or any public property, including any street or public place of the city, except as a danger warning or a signal for help; the creation by means of any such signaling device of any sound that is unreasonably loud, raucous, jarring, disturbing or a nuisance; the sounding of any such signaling device for an unreasonable period of time; the use of any such signaling device when traffic is, for any reason, held up; the use of any such signaling device except one operated by hand or electricity; and, the use of any such signaling device operated by engine exhaust.

(b) Radios, phonographs, stereos, bass amplifiers and musical instruments. Using, operating or permitting to be played, used or operated, any radio, tape recorder, cassette player, compact disc (C.D.) player, musical instrument, phonograph, loud speaker, sound amplifier or other machine, apparatus or device for the producing, reproducing or amplifying of the human voice or of any sound:

1. Upon residential property or within a residential neighborhood, whether containing one or more units of multiple-family residential dwellings or a single-family residential dwelling, and upon property containing a hotel, motel or inn, unless the volume of such sound shall be so controlled that:

- a. It will not be plainly audible at a distance of 50 feet from any building, structure, chamber or vehicle in which such machine, apparatus or device is located, and
- b. In the case of a multiple-family residential dwelling, a hotel, motel or inn, it will not be plainly audible in any adjoining unit. Provided, however, that actual notice from an occupant of the adjoining unit to the occupant of the property containing the source of amplified sound shall be a necessary element of a violation under this subsection.

2. Upon any private property that is nonresidential and that is not located within a residential neighborhood, upon any public property, including any public street, highway, building, sidewalk, park or thoroughfare or in or upon any motor vehicle on such private or public property, unless in each such instance the volume of such sound shall be so controlled that it will not be plainly audible for a distance in excess of 100 feet from the source.

(c) Exhaust. The discharge into the open air of the exhaust of any steam engine, stationary internal combustion engine, motor boat or motor vehicle, except through a muffler or other device which is properly maintained and in good working condition and which will effectively prevent any noise that is unreasonably loud, raucous, jarring, disturbing or a nuisance.

(d) Animals, birds and the like. The keeping of any animal or bird which by causing frequent or long continued noise shall disturb the comfort and repose of any person or resident.

(e) Yelling, shouting, hooting, whistling and singing. Yelling, shouting, hooting, whistling and singing or making other verbal noises on the public streets or public areas or from private property between the hours of 10:00 p.m. and 6:00 a.m. so as to be plainly audible at a distance of 50 feet from the public area or private property from which such noise emanates.

(f) Pile drivers, hammers, blowers, construction equipment and the like. The operation of any pile driver, steam shovel, pneumatic hammer, derrick, steam or electric hoist, blower, power fan or other power tools whether air, electric or gasoline powered, unless the sound produced thereby shall be so controlled that it is not plainly audible for a distance in excess of 100 feet from the source; and the operation of any internal combustion engine, unless such engine is equipped with a muffler device used and maintained in accordance with the manufacturer's specifications.

(2) Exemptions. The following activities are exempt from the application of this section:

- (a) Devices used solely for the purpose of warning, protecting or alerting the public, or some segment thereof, of the existence of an emergency situation.
- (b) Construction operation for which building permits have been issued, or construction operations not requiring permits due to ownership of the project by an agency of the government, providing all equipment is operated in accordance with manufacturers' specifications and with all standard equipment, manufacturers' mufflers and noise reducing equipment in use and in proper operating condition. However, such exception shall apply only to construction operations between the hours of 7:00 a.m. and dusk Monday through Sunday, except in case of urgent necessity in the interest of public health and safety, and then only with a permit from the Building Inspector, which permit may be granted for a

period not to exceed three days while the emergency continues and which permit may be renewed for periods of three days while the emergency continues. If the Building Inspector shall determine that the public health and safety will not be impaired by the erection, demolition, alteration or repair of any building or the excavation of streets and highways within the hours of 6:00 p.m. and 7:00 a.m. and /or Sunday, and if he or she shall further determine that hardship would result to any party in interest if permission is not granted, he or she may grant permission for such work to be done within the hours of 6:00 p.m. and 7:00 a.m. and or on Sunday upon application being made at the time the permit for the work is awarded or during the progress of work.

(c) Noises of safety signals, warning devices, emergency pressure relief valves and bells and chimes of churches.

(d) Noises resulting from any authorized emergency vehicle when responding to an emergency call or acting or operating within the scope of the authority of said agency or as is necessary for the safety of the public in time of emergency. (e) Operations by city departments.

(f) Sound emanating from duly licensed and/or authorized athletic contests, parades and city-sponsored public celebrations.

(g) Noises emanating from industrial facilities operating in industrial zoned areas of the city, provided that such noises are incidental to the normal operations of such facility and further provided that such facility is operating in accordance with all city, state and federal codes, statutes, regulations, special use permits and other enforceable orders.

(h) Noises of lawn care equipment in normal usage between the hours of 6:00 a.m. and 10:00 p.m. if used and maintained in accordance with the manufacturers' specifications.

(i) Except as set forth in subsection (C)(1), motor vehicles on public roads, but this section is not intended and shall not be construed to interfere with the enforcement of § 70.039 or any other city, state or federal statute, regulation, ordinance, code or like regulations of motor vehicles.

(j) Noises of aircraft, railroad trains, transit buses, school buses and other publicly- owned and/or operated transportation vehicles.

(k) Operations by, or sanctioned by, the proper authorities (city, state or federal) for the protection of persons or property where imminent physical trauma or property damage demands immediate action. ('79 Code, § 6-340) (Am. Ord. 762, passed 2-16-99) Penalty, see § 10.99

(l) Noises emanating from an event center in accordance with a current Conditional Use Permit from the City of La Vista, subject to the following conditions:

1. A curfew shall exist during which time no outdoor amplified sound shall be permitted. The curfew shall have the following beginning and ending times:

<u>Day of the Week</u>	<u>Beginning</u>	<u>Ending</u>
<u>Sunday through Thursday</u>	<u>10:00 pm</u>	<u>8:00 am the following day</u>
<u>Friday and Saturday</u>	<u>10:30 pm</u>	<u>8:00 am the following day</u>

Amplified sound shall mean any sound, the volume of which is increased by, or by use of, any equipment or device designed for such purpose.

(m) City, community, or other events conducted or authorized by the City.

SECTION 2. Severability Clause. If any section, subsection, sentence, clause or phrase of this ordinance is, for any reason, held to be unconstitutional or invalid, such unconstitutionality or invalidity shall not affect the validity of the remaining portions of this ordinance. The Mayor and City Council of the City of La Vista hereby declare that it would have passed this ordinance and each section, subsection, sentence clause or phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses or phrases be declared unconstitutional or invalid.

SECTION 3. Effective Date. This ordinance shall be in full force and effect from and after passage, approval and publication in book or pamphlet form or as otherwise provided by law.

BACKGROUND

On September 19, 2017, City Council approved Resolution 17-112 to approve an Interlocal Cooperation Agreement with Sarpy County and the Cities of Bellevue, Gretna, Papillion and Springfield to create the Sarpy County and Cities Wastewater Agency. On June 5, 2018 City Council approved Resolution 18-080 approving an amendment to the calendar deadlines for more flexibility to discuss and approve the Agency's Annual Budget.

Certain portions of the force main, interceptor sewer, lift stations, connection points, and related sewer infrastructure as shown on the Agency's current preliminary design for Phase 1A of the Unified SSWS are located outside of the Agency's Jurisdiction, but within portions of Sarpy County's and the City of Bellevue's extraterritorial zoning jurisdictions. The approximate location of the additional sewer infrastructure is anticipated to be located within the corridor shown on the preliminary alignment schematic attached as Exhibit B. In order for the Agency to acquire land rights for, finance, construct, equip, operate and maintain, Phase 1A of the Unified SSWS in accordance with the formation interlocal, an amendment to the formation interlocal is necessary to clarify that certain Agency powers, privileges and authority may be exercised jointly by the Agency and applicable Members outside the boundary of the Agency's jurisdiction.

SECOND AMENDMENT TO INTERLOCAL AGREEMENT CREATING THE SARPY COUNTY AND CITIES WASTEWATER AGENCY

THIS SECOND AMENDMENT TO INTERLOCAL AGREEMENT CREATING THE SARPY COUNTY AND CITIES WASTEWATER AGENCY is made by and between the County of Sarpy, Nebraska, the City of Papillion, Nebraska, the City of Bellevue, Nebraska, the City of Springfield, Nebraska, the City of LaVista, Nebraska, and the City of Gretna, Nebraska (individually, a "Member"; collectively, the "Members"), and approved and ratified by the Sarpy County and Cities Wastewater Agency (the "Agency") in accordance with Sections XVII and XVIII(D) of the Formation Interlocal (defined below). Capitalized terms used herein shall have the same meaning as defined in the Formation Interlocal, unless otherwise specified herein.

WHEREAS, pursuant to the authority granted under the Nebraska Interlocal Cooperation Act, Neb. Rev. Stat. 13-801, et seq. (the "Act"), the Members formed and created the Agency pursuant to that certain Interlocal Agreement Creating the Sarpy County and Cities Wastewater Agency dated September 19, 2017 (as amended, the "Formation Interlocal");

WHEREAS, pursuant to Section VII of the Formation Interlocal and Agency Resolution 2019-004, the Agency approved and established the Agency's Jurisdiction over the "Service Area" depicted on the map attached hereto as **Exhibit A**, and, pursuant to separate government action, all the Members' respective governing bodies subsequently approved and adopted the Agency's Jurisdiction;

WHEREAS, pursuant to Section V(A) of the Formation Interlocal, the Agency has the power and authority to "acquire real property, or such other property rights as may be necessary, by gift, grant, purchase, or condemnation, as necessary for the construction and operation of the Unified SSWS...";

WHEREAS, pursuant to Section VII(B) of the Formation Interlocal, the "Agency is not limited to financing, constructing, equipping, operating, and maintaining a sewer system exclusively within the Agency's Jurisdiction";

WHEREAS, the Act provides that "[a]ny power or powers, privileges, or authority exercised or capable of exercise by a public agency of this state may be exercised and enjoyed jointly with any other public agency";

WHEREAS, certain portions of the force main, interceptor sewer, lift stations, connection points, and related sewer infrastructure ("Additional Sewer Infrastructure") as shown on the Agency's current preliminary design for Phase 1A of the Unified SSWS are located outside of the Agency's Jurisdiction, but within portions of Sarpy County's and the City of Bellevue's extraterritorial zoning and planning jurisdictions. The approximate location of the Additional Sewer Infrastructure is anticipated to be located within the corridor shown on the preliminary alignment schematic attached hereto as **Exhibit B**;

WHEREAS, in order for the Agency to acquire land rights for, and to finance, construct, equip, operate and maintain, Phase 1A of the Unified SSWS in accordance with the Formation

Interlocal and applicable Agency resolutions, policies and procedures, the Agency and the Members desire to amend the Formation Interlocal to clarify that certain Agency powers, privileges and authority may be exercised jointly by the Agency and applicable Members outside the boundary of the Agency's Jurisdiction;

WHEREAS, pursuant to Sections XVII and XVIII(D) thereof, the Formation Interlocal may be amended by a written amendment by the governing bodies of all the Members of the Agency, and the approval of resolutions adopting the terms of such amendment by the governing body of each Member;

WHEREAS, the Agency Board and the Members have determined that an amendment to the Formation Interlocal is necessary for the Agency to carry out its purposes; and

WHEREAS, on the terms set forth herein, the Members agree to amend the Formation Interlocal on the terms and conditions set forth herein.

NOW, THEREFORE, in consideration of the mutual covenants contained herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledge, the Members agree as follows:

1. **Incorporation of Recitals.** The recitals set forth above are incorporated herein by this reference.

2. **Land Rights Acquisitions for Additional Sewer Infrastructure.** Section XIII of the Formation Interlocal is hereby amended by adding the following new subsection (D) to the end of said Section XIII:

“D. Pursuant to Sections V, VII and XIII of this Agreement, the Agency is authorized and empowered to, among other things, acquire real property, or such other property rights as may be necessary, by gift, grant, purchase, or condemnation, as necessary for the financing, construction, equipping, operation, and maintenance of the Unified SSWS located within and outside the Agency's Jurisdiction; provided, however, that the acquisition of real property, or such other property rights, for portions of the Unified SSWS (including, but not limited to, the Additional Sewer Infrastructure) located outside of the Agency's Jurisdiction and within a Member's corporate limits, declared extraterritorial zoning jurisdiction, wastewater service area designated per interlocal agreement, or areas that lie within a Member's “area of future growth and development” under maps adopted under the County Industrial Sewer Construction Act, Neb. Rev. Stat. § 23-3601, et seq., shall require approval by the Agency and the governing body of each Member where the land upon which such portions of the Unified SSWS (including, but not limited to, the Additional Sewer Infrastructure) are located. The powers, privileges and authorities granted pursuant to this section and elsewhere in this Agreement may be exercised and enjoyed jointly by the Members with the Agency. Such real and other property rights acquired pursuant to this section shall be held in the name of the Agency.”

3. **Cooperation.** The Agency and Members agree to execute and deliver all documents, provide all information, and take or forebear from such action as may be necessary or appropriate to achieve the purposes of this Second Amendment, and they shall further perform the applicable provisions of this Second Amendment in good faith and with due diligence and in cooperation with the other party. The Members shall refrain from taking any action that is inconsistent with the terms hereof.

4. **Effective Date.** This Second Amendment shall not be effective before the occurrence of the latter of the separate approving actions by each Member's governing body are taken, which approvals shall include all actions of each Member prior to such date taken in reliance upon and in accordance with the terms of this Second Amendment, and each Member shall furnish to the Agency a certified copy of the resolution of its governing body. This Second Amendment shall be in full force and effect as of the date of execution hereof by the last of the parties hereto and shall continue until terminated by mutual agreement of the parties hereto.

This Second Amendment to the Formation Interlocal is authorized by the vote and approval of the Agency and each Member at public meetings duly held in accordance with applicable law, and the following execution by their respective authorized representatives.



Growth Management Plan





BACKGROUND

Over the past few years, the Streets Division has had the capability of sending out two separate crews with hot boxes to do asphalt patching and small overlays. The hot boxes utilized are a 2018 4-ton Falcon hot box and a 2009 2-ton Spaulding hot box that was originally purchased as a used demo unit. The Spaulding hot box has had electrical system and burner unit issues, with repairs totaling over \$9,000 in parts and labor. This causes delays in asphalt patching as this unit can be down for multiple days at a time. The Capital Equipment Committee has recommended the replacement of this unit with a larger capacity 4-ton Falcon unit similar to the 2018 unit.

The proposed equipment will be purchased through the Nebraska State Bid, contract #14934 OC.

DISCUSSION – DOG PARK AT LIBRARY/METRO CC SITE	◆ RESOLUTION ORDINANCE RECEIVE/FILE	JOE SOUCIE PUBLIC WORKS DIRECTOR

SYNOPSIS

Subsequent to a citizen request to locate a dog park on land north of and immediately adjacent to Southwind Park and the La Vista Public Library/ Metro Community College Sarpy Center, staff has collected information for review and discussion.

FISCAL IMPACT

Funds are available in the FY21 budget for the initial establishment of a dog park. Approximate total cost is \$6,600.

RECOMMENDATION

Approval on a trial basis.

BACKGROUND

The Mayor and City Council have had previous discussions regarding the potential of locating a dog park in the City and have considered several sites. During FY20 staff put together plans to initiate a “pop-up” dog park location(s) in an effort to determine if and where a “park” such as this might be successful. One of the sites considered during this process was the land north of and adjacent to the Library/Metro Community College Sarpy Center. This land is jointly owned by the City and MCC.

At a City Council meeting on January 19, 2021 two citizens addressed the Council requesting that a dog park be located in the area mentioned above. Council asked for additional information, which staff has compiled.

Public Works has identified a proposed location (map attached) and an initial cost estimate. Anticipated costs include \$5,000 for temporary fencing (photo attached) to be installed and removed by a fence company, \$600 for dog waste stations, and \$1,000 for annual repair costs (overseeding, fertilizing, etc.). Companies that provide K9 waste removal services were contacted and none of them were interested in providing this service for a dog park. Upon further investigation it was determined that local dog parks are typically self-service when it comes to clean up. Signs are posted and waste stations are provided. City maintenance staff will be responsible for mowing, line trimming and overseeding the area as well as servicing the waste stations provided.

The dog park proposal was presented at a meeting of the La Vista Metro Condominium Association on February 8, 2021. Metro officials agreed to allow this on the jointly owned land on a trial basis with a reassessment in November of 2021. The Southwind Homeowners Association also submitted a letter to the City indicating their support of a dog park in this location.

The City Clerk has verified with our current liability insurance carrier that the City is covered for claims such as a dog causing bodily injury in cases where the city was liable.

Since the January 19, 2021 meeting the City has received the following feedback from citizens:

Staff recommends that a dog park be established at the proposed location with a temporary fencing installation. Signs will be posted indicating that users of the park must clean up after their dogs. The City will monitor utilization and keep track of any issues and complaints that arise. The situation will be reassessed in November of 2021 prior to making any decision as to whether it become permanent.
