SYNOPSIS

An application for payment of a portion of Economic Development Program (EDP) Award funds has been submitted by City Centre Music Venue, LLC and Astro Theater, LLC for work completed to date on the Astro Theater in the amount of \$268,288.26.

FISCAL IMPACT

The FY21/22 Biennial Budget provides funding for the EDP award for the Astro Theater project.

RECOMMENDATION

Approval.

BACKGROUND

On September 3, 2021 an Economic Development Program Agreement was executed by the City of La Vista, City Centre Music Venue, LLC and Astro Theater, LLC, authorizing an EDP award of up to \$5,500,000 to be used in conjunction with other funding sources for constructing and equipping the Astro Theater project.

Subsequently, on December 17, 2021 an Amended and Restated Disbursement Agreement was executed by all parties directing how funds, including the EDP award from the City of La Vista, would be disbursed. The agreement outlines several requirements that must be met prior to any disbursement of funds.

Construction of the Astro Theater commenced this fall, and the City has received a second request for payment* of EDP funds for the project in the amount of \$268,288.26. City staff has reviewed the documentation submitted with the pay request to assure compliance with the disbursement agreement and has obtained copies of all documents required by the agreement. The City Engineer and Chief Building Official have reviewed the pay request documentation and verified that it coincides with the construction progress they have observed on site. Copies of all documentation are on file in the office of the City Clerk.

As construction progresses and additional pay requests are submitted for the remainder of the EDP award, we will continue to follow the process of ensuring that all required documentation has been received and that completed work has been verified by the City Engineer and the Chief Building Official. Subsequent to those verifications, pay requests will be placed on the Council agenda for approval.

*Note: The Application for Payment indicates this is Pay Request No. 4, however this is the second request for disbursement of EDP funds from La Vista. City Centre Music Venue LLC is required by the disbursement agreement to use this application for payment requests from all lending agencies as well as the City of La Vista, resulting in the requests being numbered consecutively as they are issued.

SYNOPSIS

A resolution has been prepared to authorize an agreement with The Brian Slobotski Memorial Foundation dba Brian Smiles for storm water public education & outreach services in an amount not to exceed \$3,000.

FISCAL IMPACT

The FY21/22 Biennial Budget provides funding for the proposed services.

RECOMMENDATION

Approval.

BACKGROUND

Public education and outreach efforts are required as part of the NPDES permit for MS4 public storm water discharges. A joint agreement has been in place with the City of Papillion since 2016 to partner on providing said services. An agreement was not executed in 2021 because of pandemic restrictions.

Previously, this agreement was conducted through Civic Nebraska. This year and moving forward staff recommend that this contract be executed with the non-profit firm of “Brian Smiles”. The Brian Slobotski Memorial Foundation dba Brian Smiles is a Nebraska 501(c)(3) non-profit that focuses on the support of families living with any of 44 neuro-muscular diseases. It was created in memory of Brian Slobotski who passed away in 2013. Brian Smiles has deep ties to the community. It is a volunteer non-profit with members representing public education, state-wide non-profits, entrepreneurs, fire departments, marketing, and sales. Kent Day, who is with Civic Nebraska, has been running this project for the past 8 years and has the network in place to take over immediately.

Brian Smiles will prepare informational materials, arrange and conducting or attend various public outreach events as well as documentation and reporting.

To maximize the outreach efforts with a limited amount of funding, the City will once again partner with the City of Papillion. The agreement provides for each City to be responsible for 50 percent of the consultant services. The total cost is \$6,000.

Agreement for Consultant Services
Papillion-La Vista Storm Water Management
2022 Papillion-LaVista Stormwater Outreach & Public Education

This Agreement for consultant services is entered into as of February 15, 2022 by and between Brian Smiles (hereinafter called BS) and the City of La Vista, Nebraska (hereinafter called La Vista) and the City of Papillion, Nebraska (hereinafter called Papillion). It is understood by the parties to this Agreement that the consultant services described herein will be performed by BS under the auspices of "Papillion-LaVista Stormwater Outreach" (PLVSO).

Section 1: Consultant Duties – Consultant shall provide the following services:

In order to address the public education and outreach obligations of La Vista and Papillion under their respective MS4 storm water discharge permits, La Vista and Papillion are partnering to engage the services of BS to include the following:

Outreach and Event Participations and Hosting

1. Host informational tables at 3 events related to storm water management including the Nebraska Science Fest, World-O-Water, and the La Vista Public Works Open House. Additional school events are to be determined.
2. Create and maintain a website dedicated to storm water management information and outreach including basic search engine optimized with data updates weekly, monthly; mobile and tablet optimized.
3. Robust social media outreach

Engagement Initiatives and Programs

1. Participate in rain barrel projects
2. Pursue additional funding with an emphasis on school-age projects relating to storm water management.

Procedures

1. Train BS staff to host informational tables.
2. Provide at least 2 table hosts at each event to engage the community.
3. Distribute handouts, brochures, and literature provided by Papillion and La Vista.
4. Display PLVSO banners at events for project identification purposes.
5. Obtain items for incentives/give-aways at events to promote citizen engagement to the extent that funding is available.
6. Provide chairs and a canopy as required for table hosts at events.

Documentation and Reporting

1. Create reports including data on community participation at all events such as the number of citizens engaged, number of brochures distributed, number of give-aways and hours and dates of events.
2. Provide data on all virtual contacts including citizens' visits to the website, activity on social media, and email distribution.
3. Prepare a final report of all efforts completed under this Agreement. This report shall be due by February 28, 2023. Papillion and La Vista will use this information to prepare their annual storm water management reports to the Nebraska Department of Environmental Quality and required under their respective MS4 permits.

Section II: Papillion and LaVista Duties – Papillion and La Vista shall provide the following:

1. Provide publicity via Papillion and La Vista web sites and other media outlets.
2. Provide access to creeks and streams for tours and engagement activities.
3. Print and provide storm water management brochures and other literature as needed.
4. Provide project banners for display at events.
5. Provide sample rain barrels and other storm water management devices for display at events.

Section III: Property rights and informational disclosure

Confidential information – BS shall freely disclose to Papillion and La Vista all information, data, and results obtained from work performed under this Agreement. Papillion and La Vista are free to use such information for their own internal purposes or to disclose such information to third parties. Provided, however, if the work performed pursuant to this Agreement requires disclosure of information which any party hereto considers as proprietary and confidential, the parties agree that separate confidentiality agreements may be executed with the individual participants in the project.

Rights in Data-Progress reports may be prepared at various times detailing the results of the project to date. These reports will become the property of Papillion and/or La Vista and will not be distributed by BS without written approval.

Section IV: Independent Contractor Statement

BS and anyone that BS hires for assistance are not and shall not be considered employees of Papillion or La Vista. BS shall be and remain an independent contractor and nothing constrained in the Agreement shall be construed inconsistent with that status. Notwithstanding such status, any employee shall be removed from any job site by BS at any time on request of Papillion or La Vista for incompetence, neglect of duty, or misconduct. Papillion and La Vista shall have no other control over the employment, compensation, or discharge of BS's employees or agents.

Section V: Insurance

BS shall purchase and maintain insurance as will protect BS from claims set forth below which may arise out of, or result from, BS's execution of the services in this Agreement, whether such execution be by BS or by anyone directly or indirectly employed by BS.

1. Claims under workman's compensation, disability benefit and other similar employee benefit acts.
2. Claims for damages because of bodily injury, occupational sickness, or disease, or death of BS's employees.
3. Claims for damages because of bodily injury, sickness or disease, or death of any person other than BS's employees.
4. Claims for damages insured by usual personal injury liability coverage which are sustained by any person as a result of an offense directly or indirectly related to the employment of such person by BS.
5. Claims for damages because of injury to, or destruction of, tangible property including loss of use resulting therefrom.
6. Claims for damages because of bodily injury or death of any person or property damage arising out of the ownership, maintenance or use of any motor vehicle.

Personal property insurance shall be the responsibility of the owner of the property regardless of the location of the loss.

Section VI: Indemnification

BS agrees to indemnify, defend, and hold harmless Papillion and La Vista or their officers, agents, and employee from any and all claims, demands, actions, damages, liability, and expenses in connection with loss of life, personal injury, and/or damage to property which be asserted, claimed, or recovered against or from Papillion and/or La Vista or their officers, agents, and employees by reason of any act, omission, or representation of BS or its subcontractors, agents, or employees. In turn, Papillion and La Vista agree to indemnify, defend, and hold harmless BS or its officers, agents, and employees from any and all claims, demands, actions, damages, liability, and expense in connections with loss of life, personal injury, and/or damage to property which may be asserted, claimed, or recovered against or from Papillion and La Vista or their officers, agents, or employees by reason of any act, omission, or representation of Papillion and La Vista or their officers, agents, and employees. This clause shall survive the expiration or termination of this Agreement.

Section VII: Term of Agreement and Termination

This Agreement commences February 15, 2022 and ends February 28, 2023 unless extended

by mutual Agreement of all parties. Papillion and La Vista reserve the right to terminate this Agreement early without penalty, damages, or cause. Services up to the point of termination will be compensated accordingly to the terms outlined below but under no circumstances shall any outstanding services not rendered be paid.

Section VIII: Payment for Services

In consideration of the foregoing, Papillion and La Vista will reimburse BS for all direct costs incurred in the performance of this Agreement, which shall not exceed a total cost of \$6,000. Papillion will be responsible for \$3,000 of the total cost and La Vista will be responsible for \$3,000 of the total cost.

BS will provide monthly invoices to Papillion and La Vista for actual costs incurred within the limits of the above-stated total cost. Payment shall be made to BS within thirty (30) days of receipt of invoices. BS shall bill Papillion and La Vista at the same time and in equal amounts for the services set forth in this Agreement. Invoices shall include a narrative and itemization of the costs of the services, materials, and wages covered by the invoices. Invoices shall be sent to:

Section IX: Notices

All notices to be given to any party under this Agreement shall be sent to the parties listed in Section VIII above.

Section X: Assignment

This Agreement is non-assignable and non-transferable. Any attempt by any party to assign its obligations hereunder shall be void.

CONTRACT

THIS AGREEMENT made and executed in quadruplicate, this 15th day of February 2022, by and between the City of La Vista, hereinafter referred to as "Owner" and McAnany Construction Inc., hereinafter referred to as "Contractor".

WITNESSETH:

In consideration of the following mutual agreements and covenants to be kept by each party, the Contractor agrees to furnish all tools, equipment, labor, materials, transportation and permits required to construct the 2022 UBAS Street Maintenance Project in accordance with the aforesaid plans and specifications for the following unit prices:

Contractor shall also furnish all bonds and insurance certificates and pay all permit fees and any other charges levied or required by any governmental authority exercising control over this project.

On or about the first and third Wednesday of each month, the Owner will pay the Contractor **ninety (90) percent** of the value of the work completed as of the end of the preceding payment period, as certified by the Engineer. The balance will be paid upon final completion of the work and formal acceptance by the Owner and Engineer.

Contractor must furnish a **one-hundred (100) percent** Contract Performance Bond and a **one-hundred (100) percent** Labor and Material Payment Bond (including **two (2) year** Maintenance Guarantee) in accordance with the General Conditions of the Contract. Contractor must also furnish a Certificate of Insurance for Worker's Compensation and Public Liability Insurance and Auto Insurance in the manner and with minimum limits as set forth in the General Conditions of the Contract.

Contract is let subject to the following conditions:

Contractor agrees that the work shall be completed within a mutually acceptable sequence and schedule as determined by the City Engineer. As time is of the essence, for each **calendar** day that any work shall remain uncompleted after the above specified completion date, the Contractor shall pay to the Owner the sum of **five hundred dollars (\$500)** per **calendar** day, not as a penalty, but as predetermined and agreed liquidated damages.

This contract for the 2022 UBAS Street Maintenance services between City of La Vista Public Works and the Contractor may be extended on an annual basis for up to ten (10) years if mutually agreed to in writing by both the Contractor, and owner, City of La Vista Public Works. Each annual extension will allow for a negotiated and agreed upon increase/decrease in pay items based on national inflation average, increase in labor rates, equipment costs and fluctuation in material pricing. Extension will be agreed upon no later than January 31st of the next calendar year to allow for pricing to be secured.

During the performance of this contract, the contractor, for itself, its assignees and successors in interest (hereinafter referred to as the "contractor") agrees as follows above and beyond the bid procurement documents (Plans and Specification):

- (1) A fully dedicated crew will be provided to the City of La Vista and will work 4 to 5 days per week to complete all work identified by the City Engineer until the contracted amount of Base Bid items have been completed.
- (2) The Contractor's crew shall consist of at least five (5) staff and management personnel.
- (3) Traffic control will be provided to a level identified by the City Engineer which is considered safe and acceptable to everyone without argument or change order request.
- (4) Notice to neighbors affected by driveway restrictions will be solely a Contractor responsibility to coordinate and confirm with the City Engineer.
- (5) Compliance with Regulations: The contractor shall comply with the Regulation relative to nondiscrimination in Federally-assisted programs of the Department of Transportation (hereinafter, "DOT") Title 49, Code of Federal Regulations, Part 21, and the Federal Highway Administration (hereinafter "FHWA") Title 23, Code of Federal Regulations, Part 200 as they may be amended from time to time, (hereinafter referred to as the Regulations), which are herein incorporated by reference and made a part of this contract.
- (6) Nondiscrimination: The Contractor, with regard to the work performed by it during the contract, shall not discriminate on the grounds of race, color, or national origin, sex, age, and disability/handicap in the selection and retention of subcontractors, including procurements of materials and leases of equipment. The contractor shall not participate either directly or indirectly in the discrimination prohibited by 49 CFR, section 21.5 of the Regulations, including employment practices when the contract covers a program set forth in Appendix B of the Regulations.
- (7) Solicitations for Subcontractors, Including Procurements of Materials and Equipment: In all solicitations either by competitive bidding or negotiation made by the contractor for work to be performed under a subcontract, including procurements of materials or leases of equipment, each potential subcontractor or supplier shall be notified by the contractor of the contractor's obligations under this contract and the Regulations relative to nondiscrimination on the grounds of race, color, or national origin, sex, age, and disability/handicap.
- (8) Information and Reports: The contractor shall provide all information and reports required by the Regulations or directives issued pursuant thereto, and shall permit access to its books, records, accounts, other sources of information, and its facilities as may be determined by the City of La Vista, NDOT or the FHWA to be pertinent to ascertain compliance with such Regulations, orders and instructions. Where any information required of a contractor is in the exclusive possession of another who fails or refuses to furnish this information the contractor shall so certify to the City of La Vista, NDOT or the FHWA as appropriate, and shall set forth what efforts it has made to obtain the information.

(9) Sanctions for Noncompliance: In the event of the contractor's noncompliance with the nondiscrimination provisions of this contract, the City of La Vista shall impose such contract sanctions as it, NDOT or the FHWA may determine to be appropriate, including, but not limited to:

- (a) withholding of payments to the contractor under the contract until the contractor complies, and/or
- (b) cancellation, termination or suspension of the contract, in whole or in part.

(10) Incorporation of Provisions: The contractor shall include the provisions of paragraphs (1) through (6) in every subcontract, including procurements of materials and leases of equipment, unless exempt by the Regulations, or directives issued pursuant thereto.



SYNOPSIS

A resolution has been prepared authorizing a Professional Services Agreement with Felsburg Holt & Ullevig (FHU) to develop design plans for signal improvements to the intersections of 84th Street and Main Street/Brentwood Drive as well as 84th Street and City Centre Drive in an amount not to exceed \$15,675.

FISCAL IMPACT

The FY21/22 Biennial Budget includes funding for this project.

RECOMMENDATION

BACKGROUND

Working through the drafts of the Event Traffic Management Plan with the redeveloper and the recent 84th Street Traffic Study being finalized by Felsburg, Holt and Ullevig (FHU), this design will design a 4-section flashing yellow arrow (FYA) signal head for the southbound left and evaluate the lane geometry for a dual westbound left at 84th Street and Main Street/Brentwood Drive. Also, to aid in the traffic monitoring by the City of Omaha, a Pan-Tilt-Zoom (PTZ) installation will be designed to be consistent with the City of Omaha Traffic Signal system and with the PTZ cameras that currently exist along the 84th Street Adaptive Signal Corridor. A scope will provide for design of the improvements including plans and specifications, progress meetings, controller programming and signal timings. Project is anticipated to be bid after completion of the design with the goal of completing the project prior to the opening of the Astro Theatre. Attached is the scope of services for the design of the project.

Dear Mr. Dowse:

Thank you for the opportunity to submit this scope of services to develop design plans for proposed signal improvements at the intersections of 84th Street with City Centre Drive and 84th Street with Brentwood Drive/Main Street. The improvements will include a new CCTV camera at the 84th Street with City Centre Drive intersection and an overlap phase for the northbound right-turn lane.

At the intersection of 84th Street with Brentwood Drive/Main Street a new 4-section flashing yellow arrow (FYA) signal head for the southbound left-turn will be provided. Additionally, dual westbound left-turn lanes will be evaluated. Truck turning templates will be ran to determine if there are turning conflicts between the eastbound and westbound turning traffic before this improvement is designed. An overlap phase for the northbound right-turn lane will also be provided.

We are submitting this agreement for professional engineering services based on our understanding of the needed improvements as discussed. This letter agreement summarizes our understanding of the services requested, project schedule, and estimated engineering fees.

Scope of Services

FELSBURG HOLT & ULLEVIG (FHU) TO PROVIDE THE FOLLOWING SERVICES:

Task 1 – Project Management

- a. *Project Management* – The FHU Project Manager will serve as point of contact, maintain project schedule and budget, be responsible for coordinating work, and provide regular progress reports with invoices. Mark Meisinger, PE, PTOE will serve as the Principal in Charge and Adam Denney, PE, PTOE will serve as the Project Manager for this project.
- b. *Quality Assurance & Quality Control (QA/QC)* – FHU will follow defined quality assurance and quality control practices as set forth in our firm's Total Quality Management Plan.

Task 2 – Meetings

- a. *Progress Meetings* – FHU will attend monthly progress/review meetings with City of La Vista staff. Based on the project schedule, this will include two (2) meetings:
 - Project Kickoff Meeting
 - Design Progress meetings at 60%

If requested by the City, FHU can attend additional meetings to report on project progress and answer questions at our standard hourly rates.

Task 3 – Traffic Engineering

- a. *Signal Modifications* – Complete the design of signal modifications required to provide a FYA signal head for the southbound left-turn lane at the intersection of 84th Street with Brentwood Drive/Main Street and installation of a new CCTV camera at the intersection of 84th Street with City Centre Drive and overlap phases for the northbound right-turn lanes at both intersections. New load switches will be required for any new FYA signal head installed.

Additionally, dual westbound left-turn lanes will be evaluated at intersection of 84th Street with Brentwood Drive/Main Street. Truck turning templates will be ran to determine if there are turning conflicts between the eastbound and westbound turning traffic before this improvement is designed. Design improvement may include new signal heads, additional signing and striping, and modifications to medians. Should modifications to the medians be required, a supplemental will be required and include survey and additional design elements.

- b. *CFM and Controller Programming* – Per the Memorandum of Understanding (MOU) established between the City of Omaha and City of La Vista for the 84th Street ASCT system, the City of Omaha is responsible for the programming of the Conflict Monitor (CFM) and updating the controller databases for the new flashing yellow arrow heads. The City of Omaha will provide IP addresses for the CCTV. FHU will coordinate with the City of Omaha to assist with the development of these items.
- c. *Signal Timings* – FHU will develop new clearance calculations and signal timings for the proposed signal phasing.

Task 4 – Design Plan Submittals

- a. *60% Plans* – FHU shall prepare a final plan set in accordance with City of Omaha standards and specifications. Plan sheets to be included in the submittal include the following:
 - Cover Sheet
 - General Note Sheets
 - Traffic Signal Modification Sheet
 - Traffic Signal Wiring Sheet
- b. *Final Plans* – FHU shall prepare a final plan set in accordance with City of Omaha standards and specifications. This includes, but is not limited to, the following sheets:
 - Cover Sheet
 - Summary of Quantities Sheet
 - General Notes Sheet
 - Detail Sheets
 - Construction Phasing Sheets (if needed)
 - Traffic Signal Modification Sheet
 - Traffic Signal Wiring Sheet

FHU shall prepare and submit all drawings, special provisions, and cost estimate, to the City's Project Manager for the final review. Upon City acceptance of the final plans, FHU shall prepare and submit the bid package to the City's Project Manager. The bid package will include sealed drawings, sealed special provisions, and an engineer's estimate.

- c. *Quality Assurance & Quality Control (QA/QC)* – FHU will perform quality control checks prior to any design submittal on the project. QA/QC checks will be conducted in accordance with our total quality management plan.
- d. *Cost Estimates* – FHU shall prepare a detailed cost estimate for the improvements at the 60% and Final submittals.
- e. *Special Provisions* – FHU will submit Special Provisions (if necessary) with the plan submittal.

Assumptions:

- All plans and specifications for the improvements will be prepared in accordance with City of Omaha standard plans/specifications.
- City of La Vista will provide as-builts of existing roadway network and traffic signals. FHU can contact City of Omaha as needed for as-built plans.
- No survey is anticipated for this project. Plans will be developed using an aerial photo base and existing as-builts. Should modifications to the medians be required, a supplemental will be required and include survey and additional design elements.
- Construction Engineering/Materials Testing is not included in the proposal.

Letter Agreement Standard Provisions

A. SERVICES BY THE CONSULTANT

The **CONSULTANT** agrees to perform all services, hereunder, using reasonable skill and judgment in accordance with applicable professional standards. **CONSULTANT** agrees to keep the **CLIENT** informed on its progress through periodic reports, and to maintain accurate records relating to its services for this project.

The **CONSULTANT** agrees to provide, directly or by association with such other Consultants or Contractors as it may deem necessary to further the interest of the **CLIENT**, the basic services as described in the Scope of Work provided in the signed Letter Proposal or Letter Agreement.

B. RESPONSIBILITIES OF THE CLIENT

The **CLIENT** shall provide and make available to the **CONSULTANT**, for his use, all maps, property descriptions, surveys, previous reports, historical data, and other information within its knowledge and possession relative to the services to be furnished hereunder. Data so furnished to the **CONSULTANT** shall remain the property of the **CLIENT** and will be returned upon completion of its services.

The **CLIENT** shall make provisions for the **CONSULTANT** to enter upon public and private properties as required for the **CONSULTANT** to perform its services hereunder.

C. EXTRA WORK

The **CLIENT** may desire to have the **CONSULTANT** perform work or render services other than those provided in Scope of Work. This will be Extra Work. Work shall not proceed until so authorized by the **CLIENT**. Payment for all work under this Agreement shall be on an hourly basis plus expenses in accordance with the attached rate schedule. Charges for outside services, expenses, and subconsultant work will be billed at 1.10 times the invoice amount.

D. TIME OF BEGINNING AND COMPLETION

Execution of the Letter Proposal is authorization by the **CLIENT** for the **CONSULTANT** to proceed with the work (Time of Beginning). The original Time of Completion is as noted in the Letter Agreement.

E. PAYMENT

Unless otherwise provided herein, **CONSULTANT** shall submit monthly invoices for Basic, Additional or Special Services and for Reimbursable Expenses each month for work that has been performed. If hourly, invoices will be based on labor and expenses incurred. If lump sum, invoices will be based on the percentage of work completed.

~~Payments not made within 60 days of the billing date shall bear interest at the rate of 1% per month which is an annual interest rate of 12%. If any portion of, or an entire account remains unpaid 90 days after billing, the **CLIENT** shall pay all costs of collection, including reasonable attorney's fees.~~

F. DELAYS

If the **CONSULTANT** is delayed at any time in the progress of work by any act or neglect of the **CLIENT** or its agents, employees or contractors, or by changes in the work, or by

extended reviews by the **CLIENT**, fire, unavoidable casualties, or by any causes beyond the **CONSULTANT'S** control, the time schedule shall be extended for a reasonable length of time, and **CONSULTANT'S** compensation may be subject to renegotiation for increased expenses due to escalation of prices, extended services, rework, and/or other expenses incidental to such delays.

G. OWNERSHIP OF DOCUMENTS

All drawings, specifications, reports, records, and other work products developed by the **CONSULTANT** associated with this project are instruments of service for this project only and shall remain the property of the **CONSULTANT** whether the project is completed or not. The **CONSULTANT** shall furnish originals or copies of such work product to the **CLIENT** in accordance with the services required hereunder. Reuse of any of the work product of the **CONSULTANT** by the **CLIENT** on an extension of this project or on any other project without the written permission of the **CONSULTANT** shall be at the **CLIENT'S** risk and the **CLIENT** agrees to defend, indemnify, and hold harmless the **CONSULTANT** from all claims, damages, and expenses including attorney's fees arising out of such unauthorized reuse by the **CLIENT** or by others acting through the **CLIENT**. Any reuse or adaptation of the **CONSULTANT'S** work product shall entitle the **CONSULTANT** to equitable compensation.

H. INSURANCE

During the course of the services, the **CONSULTANT** shall maintain Workmen's Compensation Insurance in accordance with the Workmen's Compensation laws of the State of Nebraska Professional Liability Insurance with a minimum coverage of \$1,000,000 per occurrence, \$2,000,000 aggregate; Automobile Liability with a combined single limit coverage of \$1,000,000; and Commercial General Liability of \$1,000,000 per occurrence, \$2,000,000 aggregate. Upon request, the **CONSULTANT** shall provide certificates of insurance to the **CLIENT** indicating compliance with this paragraph.

I. TERMINATION

Either the **CLIENT** or the **CONSULTANT** may terminate this Agreement at any time with or without cause upon giving the other party fourteen (14) calendar days prior written notice. The **CLIENT** shall within sixty (60) calendar days of termination pay the **CONSULTANT** for all services rendered and all costs incurred up to the date of termination, in accordance with the compensation provisions of this contract.

J. DISPUTES

Any claim, dispute, or other matter in question between the **CLIENT** and the **CONSULTANT**, arising out of or relating to either's obligations to the other under this Agreement, shall, if possible, be resolved by negotiation between the **CLIENT'S** representative and the **CONSULTANT** Principal-in-Charge for the Project. **CLIENT** and **CONSULTANT** each commit to seeking resolution of such matters in an amicable, professional, and expeditious manner. If a matter cannot be resolved by these parties, no later than thirty (30) calendar days after either party submits an issue in writing for resolution,

representatives from executive management of the **CLIENT** and **CONSULTANT** shall attempt to resolve the matter through additional good faith negotiations. ~~If resolution cannot be reached within an additional thirty (30) calendar days, the **CLIENT** and **CONSULTANT** agree that all such unresolved disputes shall be submitted to nonbinding mediation.~~

Pending final resolution of the dispute, the **CONSULTANT** shall proceed diligently with the performance of the Basic Services as described in Article A, as directed by the **CLIENT**, and the **CLIENT** shall continue to pay the undisputed payments due to the **CONSULTANT** for such services in accordance with the payment provisions of this Agreement.

K. GOVERNING LAW

Unless otherwise agreed in writing, this Agreement and the interpretation thereof shall be governed by the law of the State of Nebraska.

L. SUCCESSORS AND ASSIGNS

The **CLIENT** and the **CONSULTANT** each binds itself and its partners, successors, executors, administrators and assigns to the other party of this Agreement and to the partners, successors, executors, administrators and assigns of such other party with respect to all covenants of this Agreement. Neither party shall assign or transfer its interest in this Agreement without the written consent of the other.

M. EXTENT OF AGREEMENT

This Agreement represents the entire and integrated agreement between the parties and supersedes all prior negotiations and representations. Nothing herein shall be deemed to create any contractual relationship between the **CONSULTANT** and any other consulting business, or contractor, or material supplier on the project, nor obligate it to furnish any notices required under other such contracts, nor shall anything herein be deemed to give anyone not a party to this Agreement any right of action against a party which does not otherwise exist without regard to this Agreement.

N. NOTICES

All notices and instructions given by either party to the other shall be in writing, and shall be deemed to be properly served if delivered to the address of record shown below, or if deposited in the United States Mail properly stamped with the required postage and addressed to such party at the address in the Letter Proposal or Letter Agreement. The date of service of a notice sent by mail shall be deemed to be the day following the date on which said notice is so deposited. Either party hereto shall have the right to change its address by giving the other party written notice thereof.

O. ACCURACY OF SERVICES AND LIMITATION OF LIABILITY

The **CONSULTANT** shall use reasonable professional skill and judgment in providing the services, hereunder, but does not warrant that such services are without errors and/or omissions. If, during the authorized use and prudent interpretation of documents or advice furnished by the **CONSULTANT**, an error or omission is discovered within a reasonable time, the **CONSULTANT** shall be responsible for correction of any work which must be removed or altered to meet the project requirements, provided the **CONSULTANT** is given a

reasonable opportunity to make remedial recommendations and to correct or arrange for the correction of the work itself. The **CONSULTANT** will not be liable for the cost of procurement of work or services performed in correcting such errors and/or omissions where such work or services result in a value to the Project over and above that which the original work or services provided.

In providing opinions of probable construction cost, the **CLIENT** understands that the **CONSULTANT** has no control over costs or the price of labor, equipment, or materials, or the Contractor's method of pricing, and that the opinions of probable construction costs provided herein are to be made based on the **CONSULTANT'S** qualifications, and experience. The **CONSULTANT** makes no warranty, expressed or implied, as to the accuracy of such opinions as compared to bid or actual costs.

The **CONSULTANT** agrees, to the fullest extent permitted by law, to indemnify and hold the **CLIENT** harmless from any damage, liability or cost (including reasonable attorneys' fees and costs of defense) to the extent caused by the **CONSULTANT'S** negligent acts, errors or omissions in the performance of professional services under this Agreement and those of his or her subconsultants or anyone for whom the **CONSULTANT** is legally liable.

The **CLIENT** agrees, to the fullest extent permitted by law, to indemnify and hold the **CONSULTANT** harmless from any damage, liability or cost (including reasonable attorneys' fees and costs of defense) to the extent caused by the **CLIENT'S** negligent acts, errors or omissions and those of his or her contractors, subcontractors or consultants or anyone for whom the **CLIENT** is legally liable, and arising from the project that is the subject of this Agreement. **CLIENT'S** amount of indemnity or costs incurred in providing the indemnity shall be limited to the same amount as the **CONSULTANT'S** liability is listed below.

As negotiated as a part of this Agreement, to the fullest extent permitted by law, and notwithstanding any other provision of this Agreement, the total liability, in the aggregate, of the **CONSULTANT** and the **CONSULTANT'S** officers, directors, partners, employees, agents and subconsultants, to the **CLIENT** and anyone claiming by, through or under the **CLIENT**, for any and all claims, losses, costs or damages of any nature whatsoever arising out of, resulting from or in any way related to the Project or the Agreement from any cause or causes, including but not limited to the negligence, professional errors or omissions, strict liability, breach of contract or warranty, express or implied, of the **CONSULTANT** or the **CONSULTANT'S** officers, directors, employees, agents or subconsultants, or any of them, shall not exceed the total amount of \$100,000.

Upon execution of the Letter Agreement or Letter Proposal, the **CLIENT** thereby agrees to the terms of these Special Provisions.

A resolution has been prepared to approve a change order to the contract with Heimes Corporation to provide for quantity additions and deletions, for an increased amount of \$6,414.05 and a total project amount not to exceed \$843,750.50.

BACKGROUND

A contract with Heimes Corporation was approved on December 21, 2021 to complete the Central Park East portion of the Thompson Creek channel rehabilitation project. In early phases of shop drawing submittal, it was discovered that the quantity of Armorflex required for the project would be notably more than plan quantity as bid. However, certain quantity deletions, such as a reduction of the gabion baskets required near Edgewood Drive and with the Park View Boulevard connection to Central Park anticipated to be bid in the near future, a reduction of quantities offset the majority of the cost increases. There were also additional portions of trail removal and replacement that were added to the project to provide for a higher quality trail section until the Edgewood access portion of Central Park road rehabilitation is anticipated to be shifted out to a later phase of work.

Change Order No. 1 increases the contract amount not to exceed by 0.76% or \$6,414.05 for a revised total in an amount not to exceed of \$843,750.50.

Reasons for Changes:

The quantity of Armorflex required for the project was underestimated by TD2. Portions of the existing asphalt trail were going to be saved in anticipation of replacement very soon with another project, however; that project may be delayed and providing a good quality trail for a period of time is desirable. Stone filled gabion baskets were proposed in an attempt to save several pine and spruce trees near Edgewood Blvd, but it was determined that impact to the roots of the trees would be too harmful, so some of the gabions and related fencing are being deleted. Additional trees were removed and earthwork quantities increased. At the west end of the Central Park roadway a partial cul-de-sac constructed of 7" concrete was proposed, but the access road to the Astro Theater will be constructed later this year making a temporary crushed rock turn-around sufficient.

Clarification:

Heimes Corp. will install and remove a temporary pipe for storm water management. This will be done as part of the Water Management, Contract Item 39, for no additional cost.
