LA VISTA CITY COUNCIL MEETING JULY 3, 2012

A meeting of the City Council of the City of La Vista, Nebraska was convened in open and public session at 7:00 p.m. on July 3, 2012. Present were Councilmembers: Sell, Ronan, Quick, Sheehan, Carlisle, Crawford, and Gowan. Also in attendance were City Administrator Gunn, Assistant City Administrator Ramirez, City Attorney McKeon, City Clerk Buethe, Police Chief Lausten, Fire Chief Uhl, Public Works Director Soucie, Community Development Director Birch, Finance Director Lindberg, Recreation Director Stopak, Public Building and Grounds Director Archibald, Library Director Barcal, and City Engineer Kottmann.

A notice of the meeting was given in advance thereof by publication in the Times on June 20, 2012. Notice was simultaneously given to the Mayor and all members of the City Council and a copy of the acknowledgment of the receipt of notice attached to the minutes. Availability of the agenda was communicated to the Mayor and City Council in the advance notice of the meeting. All proceedings shown were taken while the convened meeting was open to the attendance of the public. Further, all subjects included in said proceedings were contained in the agenda for said meeting which is kept continuously current and available for public inspection at City Hall during normal business hours.

Mayor Kindig called the meeting to order and led the audience in the pledge of allegiance.

REPORTS FROM CITY ADMINISTRATOR AND DEPARTMENT HEADS

City Administrator Gunn reminded everyone of the Budget Workshops on July 16th and 18th, 2012 at 6 P.M.

Fire Chief Uhl reported that demonstrations of the new Fire Extinguisher trainer took place prior to the meeting. Councilmember Quick asked who was painting the Fire Hydrants and why they were white. Chief Uhl responded that it was MUD doing the priming and painting.

Public Works Director Soucie stated that the white is the primer painted on all the hydrants and then they will paint all the yellow and then all the red. Soucie also reported that the Slumbuster's Tournament was successful. The permanent restrooms have been locked and portable restrooms have been placed in the parks during fireworks season to prevent destruction of fixtures in the permanent restrooms.

Public Buildings and Grounds Director Archibald reported that a fan went out on the air handler for the air conditioning unit at City Hall, but it has since been fixed.

Recreation Director Stopak reported that the Slumbuster Staff would like to thank the Mayor and Council for another successful tournament and that the Recreation Department would like to thank everyone from other departments who assisted with the tournament. Stopak also reported on two upcoming events: Sunday July 8th from 1pm to 4pm is the Splashbash and the Urban Race will be held in conjunction with the City of Papillion on August 4, 2012.

Library Director Barcal reported that they were half way through the Summer Reading Program. There will also be some exhibits coming to the Library due to the awarding of a grant.

PREVIOUSLY ENACTED; TO PROVIDE FOR SEVERABILITY; AND TO PROVIDE FOR THE EFFECTIVE DATE HEREOF.

Councilmember Gowan moved that the statutory rule requiring reading on three different days be suspended. Councilmember Quick seconded the motion to suspend the rules and upon roll call vote on the motion. The following Councilmembers voted aye: Sell, Ronan, Quick, Sheehan, Carlisle, Crawford, and Gowan. The following voted nay: None. The following were absent: Ellerbeck. The motion to suspend the rules was adopted and the statutory rule was declared suspended for consideration of said ordinance.

Said ordinance was then read by title and thereafter Councilmember Sheehan moved for final passage of the ordinance which motion was seconded by Councilmember Gowan. The Mayor then stated the question, "Shall Ordinance No. 1179 be passed and adopted?" Upon roll call vote the following Councilmember voted aye: Sell, Ronan, Quick Sheehan, Carlisle, Crawford, and Gowan. The following voted nay: None. The following abstained: None. The following were absent: Ellerbeck. The passage and adoption of said ordinance having been concurred on by a majority of all members of the Council, the Mayor declared the ordinance adopted and the Mayor, in the presence of the Council, signed and approved the ordinance and the City Clerk attested the passage/approval of the same and affixed her signature thereto.

D. RESOLUTION – AMENDMENT TO PENSION PLANS – APPOINT NEW TRUSTEE

Councilmember Quick introduced and moved for the adoption of Resolution No. 12-073; A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF LA VISTA, NEBRASKA APPROVING APPOINTMENT OF WILMINGTON TRUST RETIREMENT AND INSTITUTIONAL SERVICES COMPANY AS SUCCESSOR TRUSTEE OF CERTAIN CITY RETIREMENT PLANS AND AUTHORIZING CORRESPONDING DOCUMENT AMENDMENTS.

WHEREAS, the City maintains the following retirement plans and trusts for the exclusive benefit of plan participants and their beneficiaries pursuant to Section 401(a) of the Internal Revenue Code and applicable Nebraska law:

Plan No. 107200 - The City of La Vista General Employees Defined Contribution Pension Plan and Trust,

Plan No. 106162 - The City of La Vista City Administrators' Defined Contribution Pension Plan and Trust,

Plan No. 106442 - The City of La Vista Firefighters Retirement Plan and Trust, and

Plan No. 107185 - The City of La Vista Police Officers Retirement Plan and Trust,

(collectively the "Plans"); and

WHEREAS, Vantage Trust Company, LLC is directed trustee of the Plans; and

WHEREAS, The City also maintains two additional plans - Plan No. 300510 - The City of La Vista City Administrators' 457 Deferred Compensation Plan and Trust, and Plan No. 304703 - The City of La Vista Civilian Employees Supplemental 457 Deferred Compensation Plan and Trust – for which the City of La Vista serves as trustee, which duties are carried out by the City Treasurer; and

WHEREAS, the City has been notified that the Vantage Trust Company, LLC will resign as directed trustee of the Plans effective as of July 31, 2012; and

WHEREAS, ICMA Retirement Corporation provides administrative and investment services to the Plans and has established a relationship with Wilmington Trust Retirement and Institutional Services Company, a Delaware trust company to serve as successor directed trustee, if desired by the City; and

WHEREAS, the City desires to appoint the Wilmington Trust Retirement and Institutional Services Company to serve as successor directed trustee of the Plans, effective as of July 31, 2012.

NOW, THEREFORE, BE IT RESOLVED, that the City accepts the resignation of Vantage Trust Company, LLC effective as of July 31, 2012, subject to acceptance of appointment of successor trustee and any required accountings or transfers of assets satisfactory to the City Administrator.

BE IT FURTHER RESOLVED that the Wilmington Trust Retirement and Institutional Services Company is hereby appointed to serve as successor directed trustee of the Plans effective as of July 31, 2012, subject to any due diligence and acceptance

of appointment in writing satisfactory to the City Administrator.

BE IT FURTHER RESOLVED that the Mayor and City Clerk are authorized to execute such amendments to the Plans or corresponding trust agreements or other documentation or instruments, obtain any desired accountings and take any and all other actions on behalf of the City, as necessary or appropriate to carry out the actions approved in this Resolution and to maintain the qualified status of the Plans, in form and content satisfactory to the City Administrator.

Seconded by Councilmember Carlisle. Councilmember Crawford asked if ICMA would still oversee the plan. City Clerk Buethe responded that ICMA would still oversee the plan. Councilmembers voting aye: Sell, Ronan, Quick, Sheehan, Carlisle, Crawford, and Gowan. Nays: None. Abstain: None. Absent: Ellerbeck. Motion carried.

E. DISCUSSION – COMPENSATION INFORMATION AND PAY FOR PERFORMANCE UPDATE

Assistant City Administrator Ramirez explained that the Administration was proposing a 2% base increase and a 1% salary range increase. Ramirez explained that Pay for Performance variable pay concept was not being recommended at this time and that staff can work towards this variable pay but is not ready at this time. Councilmember Crawford asked when staff will be ready to move forward with variable pay. Ramirez responded that before moving forward with variable pay, the number of core competencies needs to be reduced in the evaluation. Councilmember Sheehan stated that he wants to see staff take their time and ensure that the process is fair and correct.

At 7:28 p.m. Mayor Kindig opened the public hearing and stated the floor was now open for discussion on special assessments.

were notified to clean up their property as they were in violation of the City Municipal Code, Section 133.01, or the City would do so and bill them accordingly,
