**SYNOPSIS**

A resolution has been prepared authorizing the purchase of one (1) Rollover Protection Structure (ROPS) from Nebraska Machinery Company, Omaha, Nebraska, for amount not to exceed \$44,168.32.

**FISCAL IMPACT**

The FY15 General Fund Budget contains funding for the proposed purchase. Order is being placed now, 60-90 day delivery time on equipment, payment will be in FY 15.

**BACKGROUND**

It was recently discovered that the Rollover Protection Structure for Public Works Cat Loader #1137 was rusted and structurally insufficient. An inspection by the Cat dealership revealed that the machine could not be certified and is unsafe to operate. With the low hours on the machine along with being in generally good condition the best option was to replace the ROPS. Public Works would be unable to sell the loader without a certification. The unit is being order now because of a 60-90 day delivery period on the parts. The loader is an integral part of winter operations and needs to be operational before winter sets in.

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF LA VISTA, NEBRASKA AUTHORIZING THE PURCHASE OF ONE (1) ROLLOVER PROTECTION STRUCTURE (ROPS), FROM NEBRASKA MACHINERY COMPANY, OMAHA, NEBRASKA FOR AN AMOUNT NOT TO EXCEED \$44,168.32.

WHEREAS, the City Council of the City of La Vista has determined that the purchase of one (1) Rollover Protection Structure (ROPS) is necessary; and

WHEREAS, the FY 15 General Fund Budget provides funding for this purchase; and
