**SYNOPSIS**

A resolution has been prepared authorizing payment to the Metropolitan Utilities District for their labor, equipment, materials and services to relocate and abandon water mains, services and hydrants in the Mixed-Use Redevelopment Project Area, in an amount not to exceed \$85,000.

**FISCAL IMPACT**

The FY17 Capital Improvement Program Budget includes funding for this project.

**BACKGROUND**

The proposed demolition and site preparation requires relocation, and removal and abandonment of some of the existing water distribution system owned and operated by the Metropolitan Utilities District. The work will be billed on a time and material basis. Metropolitan Utilities District has requested a purchase order in the amount of \$85,000.00 to confirm agreement with their terms, a copy of which is attached. The La Vista Community Development Agency has approved the work for this portion of the project.

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF LA VISTA, NEBRASKA AUTHORIZING PAYMENT TO THE METROPOLITAN UTILITIES DISTRICT (MUD) FOR THEIR LABOR, EQUIPMENT, MATERIALS AND SERVICES TO RELOCATE AND ABANDON WATER MAINS, SERVICES AND HYDRANTS IN THE MIXED-USE REDEVELOPMENT PROJECT AREA IN AN AMOUNT NOT TO EXCEED \$85,000.**

**WHEREAS, the City Council of the City of La Vista has determined that the relocation and abandonment of water mains, services and hydrants in the mixed-use redevelopment project area is necessary, and**

**WHEREAS, the La Vista Community Development Agency has approved this portion of the project, and**

**WHEREAS, the FY17 Capital Improvement Program Budget includes funding for this project, and**

**WHEREAS, Subsection (c) of Section 31.23 of the La Vista Municipal Code requires that the City Administrator secure Council approval prior to authorizing any purchase over \$5,000.00.**

**NOW, THEREFORE, BE IT RESOLVED, that the Mayor and City Council of La Vista, Nebraska, do hereby authorize payment to the Metropolitan Utilities District (MUD) for their labor, equipment, materials and services to relocate and abandon water mains, services and hydrants in the mixed-use redevelopment project area in an amount not to exceed \$85,000.**

RE: Relocation work for La Vista City Centre, 84<sup>th</sup> St. and Brentwood Dr.

In consideration of the sum of \$225,000.00 paid by La Vista Community Development Agency ("Applicant") to the Metropolitan Utilities District ("District"), the District will perform the following work:

1. Relocate 275'  $\pm$  of 8" ductile iron water main in easement along S 83<sup>rd</sup> Ave. from Brentwood Dr. to the south property line of 8003 S 84<sup>th</sup> St. and reconnect 6" master service to 8003 S 84<sup>th</sup> St. (\$40,000).
2. Install 215'  $\pm$  of 8" ductile iron water main in easement along S 83<sup>rd</sup> Ave. to front the applicant's property and provide reliability to the water distribution system. This cost will be shared equally by the District and the Applicant. (\$15,000)
3. Abandon in place 2800'  $\pm$  of existing 8" ductile iron water main and remove 7 hydrants. Main to be cut off and new end of main hydrants to be installed at S 83<sup>rd</sup> St. & Summer Dr., S 83<sup>rd</sup> Ave. & Brentwood Dr., and along the east property line north of Marisu Ln. (\$30,000)
- X 4. Relocate 1,000'  $\pm$  of 8" ductile iron water main from S 83<sup>rd</sup> Ave. and Brentwood Dr. to the existing main in Marisu Ln. Relocation is planned to be performed as part of a future main extension agreement with the Applicant and all funds collected for this relocation will be applied to the main extension. (\$140,000)

All work described above will be billed on a time and material basis.

The District will accept a purchase order from the Applicant for the work. Receipt of the P.O. indicates the Applicant's agreement to the District's terms herein.
