SYNOPSIS

A resolution has been prepared authorizing the expenditure of \$30,000 from the Fire Department donation account.

FISCAL IMPACT

Funds are available in the fire department donation account.

BACKGROUND

Current fire department EKG monitors are seven to eight years old and four of the units absorbed into the fire department at the time of the merger were purchased by the La Vista Volunteer Fire Department as refurbished units. Between the maintenance required to keep them functioning, the age of technology installed & the inability to upgrade that technology, as well as the increase in call volume experienced since April of 2014, the monitors are due to be replaced.

The City of Papillion and the Fire Department have worked jointly with the City of La Vista to strategize a plan to purchase five (5) new Philips MRX monitors. The total cost of the project is \$95,576.30. The Papillion Fire Department is using budgeted funds in the amount of \$65,576.30 towards the endeavor and is requesting \$30,000 from the La Vista Volunteer donation account which was dedicated to fund things such as requested.

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF LA VISTA, NEBRASKA AUTHORIZING THE EXPENDITURE OF FUNDS FROM THE FIRE DEPARTMENT DONATION ACCOUNT FOR THE PURCHASE OF CARDIAC MONITORS IN AN AMOUNT NOT TO EXCEED \$30,000.

WHEREAS, the City Council of the City of La Vista has determined that the replacement of cardiac monitors is necessary, and

WHEREAS, Funds are available in the fire department donation account for this purchase, and

WHEREAS, Subsection (c) of Section 31.23 of the La Vista Municipal Code requires that the City Administrator secure Council approval prior to authorizing any purchase over \$5,000.00.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and City Council of La Vista, Nebraska, do hereby authorize expenditure of funds from the fire department donation account for the purchase of cardiac monitors in an amount not to exceed \$30,000.
