LA VISTA CITY COUNCIL MEETING February 17, 2009

A meeting of the City Council of the City of La Vista, Nebraska was convened in open and public session at 7:00 p.m. on February 17, 2009. REPORTS FROM CITY ADMINISTRATOR AND DEPARTMENT HEADS

City Administrator Gunn reminded Council of the Strategic Planning Session on Saturday, February 28, 2009.

City Clerk Buethe informed Council that due to the current economic situation, the Web Conference that was scheduled for March had been canceled. Buethe informed Council of statutory updates, which they would receive in the near future.

Police Chief Lausten informed Council of the death of a 22 year old at the Recreation Center on Sunday. Lausten stated a suspect has been arrested in the tree vandalism and there was a domestic violence situation recently at 84th and Harrison.

Lausten informed Council that there is \$4 billion in the stimulus plan for police, with 3 year funding of new police officers.

Public Works Director Soucie informed Council that the traffic signals at 66th and Harrison Street are complete. Beginning March 1st, work will begin on Harrison Street from 60th Street going east.

Soucie informed Council that most stimulus package projects will run through MAPA. A list of projects was submitted to the State, and both short and long term projects are back to MAPA.

Soucie informed Council that the salt supply for the City is at a comfortable level.

Councilmember Crawford asked Public Works Director Soucie if the lights on Harrison Street at 66th Street are synchronized. Soucie stated he would follow-up with the contractors to get a definite answer.

Community Development Director Birch presented the annual building report for 2008 to Council.

Recreation Director Stopak informed Council the Park and Recreation Advisory Board will meet on Wednesday, February 19, 2009 at 7:00 p.m. Stopak reminded Council of the re-scheduled Senior Valentine Lunch on February 20, 2009 at 11:30 a.m. He reminded anyone who is helping during the lunch to arrive by 10:45 a.m.

Library Director Iwan informed Council that a review of inventory at the Library will begin soon. She informed Council that toddler storytime has increased due to its popularity.

Councilmember Sell seconded the motion to suspend the rules and upon roll call vote on the motion the following Councilmembers voted aye: Sell, Ronan, Sheehan, Carlisle, Crawford, Ellerbeck, and Gowan. WHEREAS, Douglas County, Sarpy County, and the City of La Vista wish to outline their respective duties and responsibilities and the sharing of costs for the design and construction costs for this improvement.

NOW THEREFORE, BE IT RESOLVED, by the Mayor and City Council of the City of La Vista, Nebraska, authorize the Mayor to execute an Interlocal Agreement with Douglas County and Sarpy County for the repair and stabilization of Hell Creek at Harrison Street.

E. RESOLUTION – COUNCIL POLICY STATEMENT – CITY COUNCIL MEETING AGENDA PROCEDURE

Councilmember Gowan introduced and moved for the adoption of Resolution No. 09-013: A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF LA VISTA, NEBRASKA, APPROVING REPLACEMENT OF AN EXISTING COUNCIL POLICY STATEMENT.

WHEREAS, the City Council has determined that it is necessary and desirable to create Council Policy Statements as a means of establishing guidelines and direction to the members of the City Council and to the city administration in regard to various issues which regularly occur; and

WHEREAS, a Council Policy Statement entitled Preparation of City Council Meeting Agendas has been reviewed and replacement of this Council Policy Statement with a Council Policy Statement entitled City Council Meeting Agenda Procedure is recommended by the City Clerk to the City Administrator.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and City Council of La Vista, Nebraska, do hereby approve the replacement of Council Policy Statement entitled Preparation of City Council Meeting Agendas with Council Policy Statement entitled City Council Meeting Agenda Procedure, and do further hereby direct the distribution of said Council Policy Statement to the appropriate City Departments.

Seconded by Councilmember Sell. City Clerk Buethe gave an overview of the changes from the previous policy statement. Mayor Kindig explained the desire to increase the opportunity for public comment on agenda items at Council meetings; and that this was the sole purpose of the proposed changes. A form also is being proposed to handle additional public comment at meetings in an efficient manner. Those wishing to comment would complete the form upon arriving at the meeting. The Mayor then would know at which points in the meeting someone in the audience would like to address the Mayor and Council on a particular agenda item, and be able to invite the person forward at the proper times. It has been past experience that members of the public desiring to speak on a particular agenda item often miss the opportunity to speak because they are unfamiliar with the flow and procedures of the meeting and fail to recognize when the opportunity to speak arises. It is hoped that using the form would reduce the chance of someone missing the opportunity to comment, while still allowing the meeting to progress in an efficient manner. Discussion was held. The Mayor said his inclination would be to allow a member of the public to speak on an agenda item even if a form is not completed [the sign-in sheet still will be used for anyone addressing the Mayor and Council]. It was noted that the policy is not an exclusive statement on public comment at meetings, and recognized that various rules of order, decorum and procedure still will apply in any given situation. It was determined that the form which the public will complete will not ask if they are a proponent, opponent or neutral. The Planning Commission meeting of the City of La Vista was convened at 7 p.m. on Thursday, February 19, 2009, at the La Vista City Hall, 8116 Park View Boulevard. Also in attendance was Marcus Baker, City Planner; and John Kottmann, City Engineer, as well as Ann Birch, Community Development Director.

Legal notice of the public meeting and hearing was posted, distributed and published according to Nebraska law. Notice was simultaneously given to all members of the Planning Commission and a copy of the acknowledgement of the receipt of notice is attached to the minutes. All proceedings shown were taken while the convened meeting was open to the attendance of the public.

1. Call to Order

The meeting was called to order by Chairman Krzywicki at 7:02 p.m. Copies of the agenda and staff report were made available to the public.

Chairperson Krzywicki introduced and welcomed newly appointed commissioner, Jay Kramolisch.

Alternate member, Jason Nielsen, will be a non-voting commissioner tonight.

2. Approval of Meeting Minutes – January 22, 2009

Hewitt pointed out a correction in which Andsager should be included in the "aye" vote and a duplicate instance of Gahan's "aye" vote should be deleted.

4. New Business

A. Public Hearing for the 150.03 Housing Code adopted by reference - to repeal the Uniform Housing Code, 1997 Edition and adopt the International Property Maintenance Code, with amendments, 2006 Edition

i. Staff Report: Jeff Sinnett, City of La Vista Chief Building Official is requesting review of the proposed code revision to Section 150.03 of the Housing Code Adopted by Reference of the City Municipal code. This revision would replace the existing Uniform Housing Code, 1997 Edition with the International Property Maintenance Code (IPMC) 2006 Edition which is the current edition available. Also, included is a list of proposed amendments to the code, they were intended to match existing city ordinances, building and zoning codes and existing design criteria.

ii. Public Hearing: Malmquist motioned to open public hearing. Horihan seconded. Ayes: Hewitt, Krzywicki, Alexander, Circo, Andsager, Horihan, Malmquist, Nielsen, Kramolisch and Gahan. Nays: None. Public hearing opened at 7:08 p.m.

No comments were received.

Circo motioned to close the public hearing. Horihan seconded. Ayes: Hewitt, Krzywicki, Alexander, Circo, Andsager, Horihan, Malmquist, Kramolisch and Gahan. Nays: None. Public hearing closed at 7:09 p.m.

Gahan asked about private swimming pools and whether the fencing was required around the pool itself or around the yard. Baker said it is generally around the backyard perimeter; however, with a hot-tub it is often closer to the structure itself.

Gahan asked about weeds growing in excess of 12 inches. Specifically, was there a previous height requirement by the City of La Vista? Baker said the proposed height matches up with municipal code which references 12 inches.

Krzywicki wondered if a clarification to the definition of weeds was necessary, with regards to ornamental grasses. Baker said he had asked Chief Building Official, Jeff Sinnett a similar question prior to the Planning Commission hearing. At that time, Sinnett said he would exempt native grasses and treat them as a garden. However, Baker said it was at the Planning Commission's discretion to make this definition clearer.

iii. Recommendation: Hewitt motioned to recommend approval of the 150.03 Housing Code be adopted by reference to repeal the existing Uniform Housing Code and adopt the 2006 Edition International Property Maintenance Code with the amendments and changes proposed tonight. Malmquist seconded. Ayes: Hewitt, Krzywicki, Alexander, Circo, Andsager, Horihan, Malmquist, Kramolisch, and Gahan. Nays: None. Motion carried.

B. Public Hearing for the review of the One & Six Year Road Plan

i. Staff Report: Joe Soucie, Public Works Director opened recognizing John Kottman, City Engineer and Cindy Norris, Public Works Administrative Secretary for their contributions to the plan. He introduced Greg Goldman, Public Works Streets Foreman as the presenter.

Goldman presented the first two years of project plans in detail.

ii. Public Hearing: Malmquist motioned to open public hearing. Horihan seconded. Ayes: Hewitt, Krzywicki, Alexander, Circo, Andsager, Horihan, Malmquist, Kramolisch, and Gahan. Nays: None. Public hearing opened at 7:15 p.m.

Joe Soucie explained that the stimulus package currently in the news would affect road work. It is broken into two different packages: short term and long term projects. MAPA, who runs the Federal funding currently on such projects, is looking to receive approximately \$32 million in the metro area for road projects. They would use the normal split with Douglas (78%) and Sarpy (22%) Counties. This equates to approximately \$7.5 million to the area. All the cities in the area have submitted priority lists to MAPA for this funding. On the short-term list, La Vista has submitted: quiet zone improvements; 108th and Chandler Road warning lights; Giles Road retrofit. The long-term priority list includes: 66th and Giles re-construction, Giles Road interconnect, 84th and Summer Drive reconstruct. If the aquatic center should get scratched, this last project may be scrapped and we would have an opportunity to re-submit another item. If La Vista cannot come up with another federal aide item, we would at least try to keep the funds in a Sarpy County project.

With no further public comments, Malmquist motioned to close the public hearing. Gahan seconded. Ayes: Hewitt, Krzywicki, Alexander, Circo, Andsager, Horihan, Malmquist, Kramolisch, and Gahan. Nays: None. Public hearing closed at 7:35 p.m.

iii. Recommendation: Malmquist motioned to forward to City Council a recommendation to adopt the One and Six Year Road Plan as presented. Circo seconded. Ayes: Hewitt, Krzywicki, Alexander, Circo, Andsager, Horihan, Malmquist, Kramolisch and Gahan. Nays: None. Motion carried.

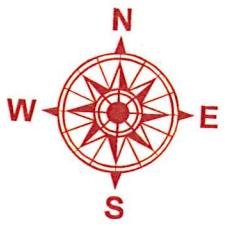

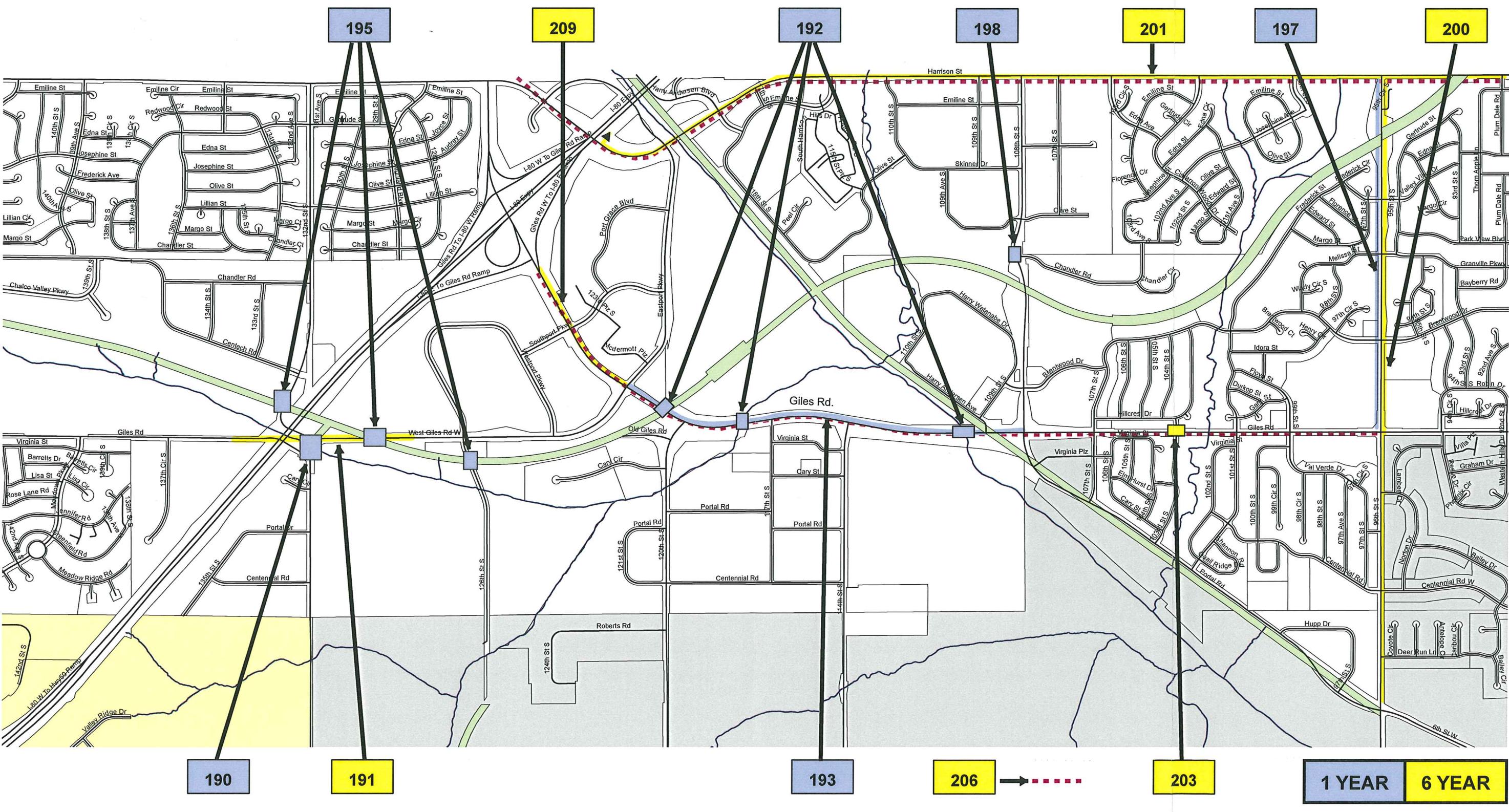
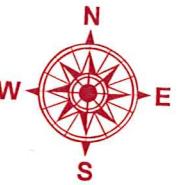

SYNOPSIS

Two resolutions have been prepared for approval of issuing conditional 2009 retail fireworks sales permits. The first resolution establishes the number of permits the City will issue. The second resolution conditionally grants permits to the organizations approved by Council.

Applications have been received from:

- La Vista Youth Football and Cheerleading
- La Vista Area Chamber of Commerce
- La Vista Youth
- La Vista Lancers Soccer Club
- La Vista Vipers Wrestling Club
- La Vista Youth Baseball Association
- St. Columbkille Shepherds, Inc.

FISCAL IMPACT

A \$2,500 permit fee is required of each applicant. Additionally, a tent permit fee of \$150, temporary sign permit fee of \$30/sign (maximum of four), and an explosive materials storage permit fee of \$100 are required. The City has received a \$500 application deposit and the additional required permit fees from each of the applicants. For each permit issued, the remaining \$2,000 fireworks sales permit fee balance is due no later than noon on June 25, 2008.

RECOMMENDATION

Approval of the applications submitted by the La Vista Youth Football and Cheerleading, La Vista Area Chamber of Commerce, La Vista Youth, La Vista Lancers Soccer Club, and La Vista Vipers Wrestling Club, stipulating their compliance with requirements made by the Chief Building Official regarding their site plan and compliance with City Code.

Denial of the application submitted by La Vista Youth Baseball Association as their location is within a Light Industrial (I-1) zoning district which does not allow fireworks stands as a temporary use.

Denial of the application submitted by St. Columbkille Shepherds, Inc. as they are not in compliance with Municipal Code Section 111.17 (C) (2) which states in part, that the use of the net proceeds from the sale of fireworks shall be for community betterment purposes within the city.

BACKGROUND

The Municipal Code Section 111.17 (A) states in part, that "Each year the City Council shall, by resolution, establish the maximum number of permits to be issued, however this number shall not in any event exceed six.

In September of 2006 a criteria/point system was created as part of the evaluation of the applications. There were no deductions to the five applications based on this point system. The two applications recommended for denial were in violation of the City Zoning regulations and City Code.

Permits will be subject to receipt of all appropriate application materials and compliance with recommendations made by City Staff.

BE IT FURTHER RESOLVED, that the written statement of income and expenses, which is required by Section 111.17 (C) (3) of the Municipal Code, be detailed and provide the City with a breakdown of specific expenditures related to the fireworks operation, income from the sale of fireworks, net profit, and specific community betterment expenditures.

BE IT FURTHER RESOLVED, that the issuance of a fireworks permit is conditional upon compliance with the Municipal Code, the Zoning Ordinance, and any other applicable regulations.

FIREWORKS

§ 111.15 DEFINITIONS.

For the purpose of this subchapter, the following definitions shall apply unless the context clearly indicates or requires a different meaning.

FIREWORKS. Any composition or device designed for the purpose of producing a visible or audible effect by combustion, deflagration or detonation and which meets the definition of common or special fireworks set forth by the United States Department of Transportation in Title 49, Code of Federal Regulations.

PERMISSIBLE FIREWORKS. Sparklers, vesuvius fountains, spray fountains, torches, color fire cones, star and comet type color aerial shells without explosive charge for the purpose of making a noise, color wheels and lady fingers not exceeding seven-eighths inch in length or one-eighth inch in diameter and which do not contain more than 50 milligrams each in weight of explosive material. The provisions of this section shall not apply to any fireworks to be used for purpose of public exhibitions or display under authorization of the city or to fireworks furnished for agricultural purposes pursuant to written authorization from the State Fire Marshal.

§ 111.16 SALE AND DISCHARGE OF NONPERMISSIBLE FIREWORKS PROHIBITED.

It shall be unlawful for any person to sell, hold for sale or offer for sale, ignite or cause to be exploded within the corporate limits of the city any fireworks or any other dangerous or combustible substance; provided, however, permissible fireworks may be sold and discharged in accordance with the following sections of this subchapter; and provided further that the City Council may authorize fireworks displays at special public gatherings under such circumstances that they will do no damage to person or property upon issuance of a display permit.

§ 111.17 SALE OF PERMISSIBLE FIREWORKS; PERMIT REQUIRED; APPLICATION; PERMIT FEE.

(A) Each year the City Council shall determine whether or not to allow fireworks stands to operate in the city. If the City Council determines that fireworks stands will be permitted, the Council shall, by resolution, establish the maximum number of permits to be issued, however this number shall not in any event exceed six.

(B) It shall be unlawful for any person to sell, hold for sale or offer for sale any permissible fireworks within the corporate limits of the city unless such person has first obtained a permit from the City Council to do so.

(C) Application for said permit shall be made in the following manner:

(1) Application shall be made on such form as shall be prescribed by the City Council and shall be filed with the City Clerk by noon on January 15 of the year for which the permit is sought. If January 15 falls on a weekend or a holiday when city offices are closed, the deadline will move to noon on the next business day. The city shall, by publication, give notice each November of the procedure and deadline for submitting a permit application.

(2) Only nonprofit organizations and associations using volunteer sales persons and which will use the net proceeds from the sale of fireworks for community betterment purposes within the city shall be eligible for a permit.

(3) If the applicant organization has held a permit in any of the three preceding years, it must file with its application a written statement of the income and expenses from the sale of its fireworks within the city for each of such years, together with a statement of its community betterment type expenditures made from the net proceeds from the sale of fireworks in each said year.

(4) The applicant shall state the nature of the community betterment purpose for which the net proceeds from the current year's sale of fireworks will be utilized if the permit be granted.

(5) The application organization must identify the proposed location for the retail fireworks stand in the permit application. A signed statement from the property owner granting the application organization permission to utilize the property must accompany the application.

(6) All applications for permits must be approved by the City Council. The City Clerk shall be responsible for reviewing applications, tallying points and making recommendations to the Council for permits. Applications will be evaluated on the following criteria/point system:

(a) Each year all applications will start out with a total of 20 points.

(b) Applications shall be automatically disqualified if they are received after the application deadline of January 15; if they are incomplete based on the checklist that is included on the application form; or if the applicant organization is a prior-year permit holder that has displayed and/or sold or attempted to sell illegal fireworks or has otherwise violated the law regarding the operation of their fireworks stand.

(c) 1. Applications that are not disqualified will be reviewed by the City Clerk and will lose points according to the following schedule:

<i>Point Deduction</i>	<i>Infraction</i>
2	Information missing from the fireworks application permit
2	Information missing from the tent permit application
2	Information missing from the sign permit application
2	Information missing from the explosive materials storage permit application
2	Information missing from the site plan
5	Lack of sufficient detail regarding proposed community betterment expenditures
5	Lack of sufficient detail regarding previous years income and expenditures
5 - 20	Concerns with proposed location based on recommendation from public safety personnel

2. In the event of a tie(s) after ranking, first preference shall be given to those eligible organizations that identify community betterment acquisitions, services or programs which will benefit the city as a whole. Those that benefit only particular areas or neighborhoods of the city shall have second preference. If all other application requirements are met, special consideration will be given to organizations agreeing to co-locate and operate a fireworks stand.

(7) Permits will be valid only for the period specified on the face of the permit and will automatically terminate on the specified ending date. Permit holders shall not have any right to or expectation of receiving a permit or operating a fireworks stand in the city in any future year or period. Notwithstanding anything herein to the contrary, permits are revocable at the will of the city, at anytime, with or without cause.

(8) As used herein, the following terms have the following meaning:

(a) **COMMUNITY BETTERMENT** shall mean that which generally betters or enhances the community of the city, such as:

1. The acquisition, improvement and maintenance of parks and recreational facilities, public equipment and other items for community use and enjoyment or to be used by the city in service to the community;
2. The recruitment and attraction of new businesses and jobs to the city community;
3. Athletic programs for the community; and
4. Other acquisitions, services or programs of general benefit to the city community.

(b) **NET PROCEEDS** shall mean gross sales less the cost of fireworks, permit fee, rental or lease expense, advertising and similar costs of operation of the fireworks stand. Volunteer salespersons shall be used and any remuneration paid or given to persons performing services in connection with the sale of fireworks shall not be deemed a cost of operation.

(9) A permit fee to sell, hold for sale or offer for sale permissible fireworks in such amount as set from time to time by the Mayor and City Council and a current record of which shall be maintained by the City Clerk, shall be collected by the city. A permit application deposit of \$500 must accompany the permit application; and, if a permit is issued, the remaining balance shall be due and payable no later than June 25 of the year for which the permit has been issued. If the permit is denied, \$400 of the deposit will be refunded.

(10) Prior to issuance of the permit, applicant shall supply to the city a copy of a certificate of insurance issued by an insurance company in good standing, authorized to do business in Nebraska, providing combined liability coverage for bodily injury and property damage in a minimum amount of \$300,000 per occurrence and \$1,000,000 in aggregate coverage and naming the City of La Vista as an additional insured.

§ 111.18 SALE OF PERMISSIBLE FIREWORKS REGULATED.

Persons holding a permit to sell permissible fireworks:

(A) May only sell the same beginning 12:01 a.m. June 25 and ending midnight on July 4 of the year for which the permit is issued. Within this period, permissible fireworks may be sold only between the hours of 8:00 a.m. and 11:00 p.m.

(B) Shall at no time sell within the city limits any fireworks or other pyrotechnics other than permissible fireworks.

(C) Shall during such times as fireworks are being sold have an adult in charge of his or her stand or retail outlet and shall display therein the required permit in a conspicuous manner and place.

(D) Shall at all times comply with all regulations passed by the City Council pertaining to the permissible size, location, equipping and operation of fireworks stands and retail outlets.

(E) Shall at no time sell any fireworks or other pyrotechnics to any person under 12 years of age. ('79 Code, § 10-314) (Am. Ord. 792, passed 10-19-99) Penalty, see § 10.99

§ 111.19 DISCHARGE OF PERMISSIBLE FIREWORKS REGULATED.

(A) *Prohibition as to time of discharge.* Except as may be otherwise provided herein or authorized by special permit approved by the City Council, no person shall ignite or discharge any permissible fireworks except between the hours of 7:00 a.m. to 10:00 p.m. from June 25 through July 3 inclusive and between the hours of 7:00 a.m. and midnight on July 4 of each year.

(B) *Dangerous environmental conditions.* In the event that in the determination of the Fire Chief, general weather or ground cover conditions are such as create an unacceptable risk of fire should there be discharge of fireworks, including permissible fireworks, within the city limits, then in such event the Fire Chief shall advise the City Administrator and Mayor of such determination and shall communicate a recommendation to them for any preventative action or measures the Fire Chief deems necessary, including what limitations should be placed upon the time period for discharge of fireworks or the extent to which the discharge of fireworks should be prohibited. The Mayor, with the advice of the Council President, the City Administrator, the Fire Chief, and the Chief of Police, or such of them as may be readily available, shall order such action, if any, the Mayor shall deem necessary or appropriate in the situation, including partial or total bans on discharge of fireworks on such dates and during such times as the Mayor may determine necessary or appropriate. Should the Mayor determine that prohibitive or preventative action is required, the Mayor shall issue a proclamation to that effect and shall advise the City Administrator, who shall advise the members of the City Council, the Fire Chief, the Chief of Police, and the media of the Mayor's proclamation and shall cause same to be conspicuously posted throughout the city. Discharge of fireworks in violation of such proclamation shall constitute a violation of this section and shall be punishable as such. As used herein, references to the Mayor and other officials shall, in the case of their absence or inability to act, include persons empowered to act in their stead.

(C) *Prohibition as to manner and place of discharge.* In no event shall any person ignite or discharge any fireworks, even though same be permissible fireworks:

- (1) In or from any motor vehicle;
- (2) On any street, highway, or sidewalk;
- (3) Near any person or group of persons;
- (4) In any building;
- (5) In any public park, except as may be authorized by special permit;
- (6) In any public building;
- (7) In any school or on any school grounds; and
- (8) In any other manner or place that is likely to inflict or increase the risk of property damage or bodily harm to any person or persons or place any of them in danger of bodily harm.

(D) Special permit for community fireworks show.

(1) The City Clerk may authorize the issuance of special permits for fireworks displays to be conducted by or under the auspices of the city or by or under the auspices of a nonprofit organization, organized for purposes of service to or betterment of the city, its businesses, or residents, for the purpose of putting on an admission-free public fireworks display for the benefit of the residents of the city at such place, during such times and under such terms, conditions, and security measures as the City Clerk may prescribe for such display.

(2) The permit holder shall obtain the required approval of the State Fire Marshal. By way of specification and not of limitation, as a condition of any permit hereunder, the permit holder shall obtain and maintain in effect, for the maximum limitations and repose periods under any and all products liability or tort laws in the State of Nebraska, insurance for any and all liabilities arising out of or resulting from any permitted fireworks or fireworks display, written by an insurer authorized to do business in the state, in such amount and upon such other terms as satisfactory to the city in its sole discretion. The city shall be an additional named insured on each such policy provided.

SYNOPSIS

A resolution has been prepared for the purchase of (1) one Toro Workman 3200 Spray Rig from Midwest Turf & Irrigation, 14201 Chalco Valley Parkway, Omaha, Nebraska 68138 for an amount not to exceed \$29,293.00.

FISCAL IMPACT

The FY 2008/09 Golf Fund provides funding for financing the purchase through the golf operating budget. \$30,000 was approved at the budget hearings for the purchase.

BACKGROUND

Council approved the purchase of this unit on October 8, 2008. At that time, Public Works did not recognize that the funding approved for financing this purchase was only for the last 6-months of the fiscal year. BACKGROUND

The Council passed Resolution 09-007 on January 20, 2009 to authorize the clerk to file special assessments with the Sarpy County Treasurer for unpaid charges for property cleanup on various properties. 7107 Monterrey Drive was one of the properties.

Since that time, the property owner has sent a letter asking that the Council reconsider the assessment.

The City gave proper notification with regard to the violation. Once the work was completed the bill was sent via certified mail which gives the property owner time to protest the bill prior to or at the Council meeting at which the assessment is presented. The Certified Letter sent to the property owner was returned to the City after the post office made three attempts to have the certified letter claimed.

Staff has reviewed similar requests from other property owners regarding the tree trimming violations and has waived the assessment. Because of the similarity of situations this is being brought back for Council reconsideration. This assessment has already been filed with the Sarpy County Treasurer and therefore if Council wants to adjust the assessment it requires action through the approval of a resolution with the amount of adjustment stated.

We have supplied the information presented at the time of the original assessment, the letter received from the property owner, and the memo from our Public Works Director regarding this clean up.

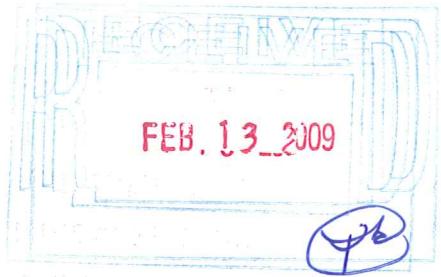

The worker claimed that it would only be about \$15 dollars to trim it anyway (he said they have to charge their hourly wage at least). My fiancé and I agreed to let him cut the one branch and they left. They were there about a total of 3 minutes.

Since then, I just received a statement for cutting that branch to the sum of \$181.72. Needless to say we are quite shocked to see such a large amount for cutting one branch off of our tree. I have no problem paying the \$15 dollars (which is what he told me) but if I knew this was going to cost almost \$200 dollars for one branch, we would have done it ourselves. We thought we did the right thing and had all of the branches cut in accordance with the city's specs. The branch he trimmed was even questionable as it barely touched his measuring

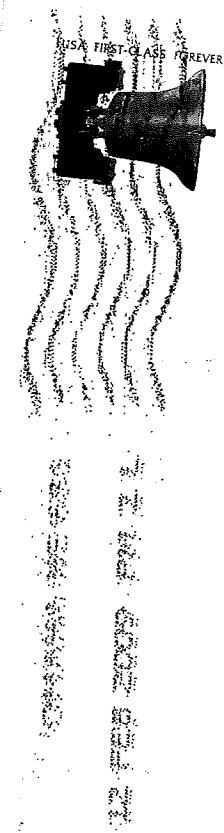

WHEREAS, the property owners of said addresses chose not to clean the property, thus necessitating the City to do the clean up, and

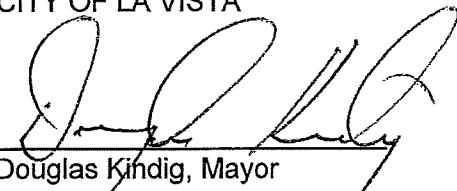
WHEREAS, the City sent the property owners bills for said clean up which have not been paid, and

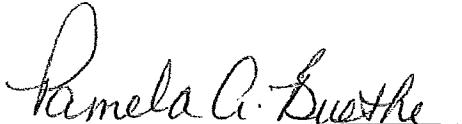
