SYNOPSIS

A resolution has been prepared awarding a contract to Western Engineering Company, Inc., Omaha, Nebraska, for the 2007 Pavement Reconstruction Program to include 84th Street and Marisu Lane Court in an amount not to exceed \$578,279.30.

FISCAL IMPACT

The FY 2006/07 Construction Fund budget provides funding for the proposed improvements.

BACKGROUND

On April 3, 2007, the City Council authorized the advertisement of bids for the 2007 Pavement Reconstruction Program. Improvements will occur on 84th Street from Harrison Street to Giles Road, and on Marisu Lane Court. Two bids were received.

Western Engineering Co., Inc.	\$578,279.30
U.S. Asphalt Co.	\$615,281.16

The City Engineer has reviewed the bids and recommends Western Engineering Company, Inc., as the low qualified bidder.

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF LA VISTA, NEBRASKA AWARDING A CONTRACT TO WESTERN ENGINEERING COMPANY, INC., OMAHA, NEBRASKA, FOR THE 2007 PAVEMENT RECONSTRUCTION PROGRAM IN AN AMOUNT NOT TO EXCEED \$578,279.30.

WHEREAS, the City Council of the City of La Vista has determined that certain pavement reconstruction is necessary; and

WHEREAS, the FY 2006/07 Construction Fund budget includes funds for the 2007 Pavement Reconstruction Program; and

WHEREAS, on April 3, 2007 the City Council authorized the advertisement of bids for said project in accordance with plans and specifications as prepared by the City Engineer; and

WHEREAS, the City Engineer has reviewed the bids and recommends that a contract be awarded to Western Engineering Company, Inc., as the low qualified bidder; and

WHEREAS, Subsection (C) (9) of Section 31.23 of the La Vista Municipal code requires that the City Administrator secure council approval prior to authorizing any purchases over \$5,000.

NOW, THEREFORE BE IT RESOLVED, by the Mayor and City Council of La Vista, Nebraska, that a contract be awarded to Western Engineering Company, Inc., for the 2007 Pavement Reconstruction Program in an amount not to exceed \$578,279.30, and that the Mayor is hereby authorized to execute said contract and the City Clerk is further directed to attest to the same.

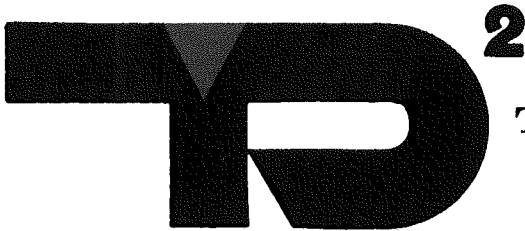

Bids were received at City Hall on April 23, 2007 at 1:30 P.M. for the above-referenced project. Two bids were received as shown on the enclosed bid tabulation.

This bid also includes the 2007 City Resurfacing program, which consists of Marisu Lane Court and is Schedule C in the bid.

Western Engineering Company, Inc. is the low bidder. Their bid was originally submitted in the amount of \$590,876.10.
