SYNOPSIS

A resolution has been prepared authorizing the purchase of a 2012 Harley Davidson Police Motorcycle – (FLHTP- Electra Glide) from Worth Harley Davidson (Kansas City) in an amount not to exceed \$18,767.00.

FISCAL IMPACT

This purchase will be expensed to the FY11/12 General Fund budget and covered by a grant from the Nebraska Office of Highway Safety.

RECOMMENDATION

BACKGROUND

The police department has received a grant from the Nebraska Office of Highway Safety for the continued implementation of a motorcycle patrol project. Funding from the Nebraska Office of Highway Safety will fund the purchase of one police motorcycle. With the increase in commercial and residential development in the city, on-going concerns about speed enforcement need to continue to be addressed. The FY12 budget projected the acquisition of a police motorcycle through a Highway Safety grant.

On December 7, 2011, bids were opened at La Vista City Hall and Worth Harley Davidson (Kansas City) is the low compliant bidder. The motorcycle carries a two year warranty.

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF LA VISTA, NEBRASKA, AUTHORIZING THE PURCHASE OF ONE (1) 2012 HARLEY DAVIDSON POLICE MOTORCYCLE FOR THE POLICE DEPARTMENT FROM WORTH HARLEY DAVIDSON, KANSAS CITY, MISSOURI, IN AN AMOUNT NOT TO EXCEED \$18,767.00.

WHEREAS, the City Council of the City of La Vista has determined that the purchase of a Harley Davidson motorcycle for the Police Department is needed; and

WHEREAS, the FY12 Budget did include grant funds for the purchase of said motorcycle; and

WHEREAS, proposals have been received and after review by the Police Chief it has been determined that the bid submitted by Worth Harley Davidson for a 2012 Harley Davidson "Police Model" FLHTPI was the low, compliant bid; and

WHEREAS, Subsection (C) (9) of Section 31.23 of the La Vista Municipal Code requires that the City Administrator secure Council approval prior to authorizing any purchase over \$5,000.00.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and City Council of La Vista, Nebraska, do hereby authorize the purchase of one 2012 Harley Davidson Police Motorcycle for the Police Department from Worth Harley Davidson, Kansas City, Missouri, in an amount not to exceed \$18,767.00.
